BAC RESOLUTION NO. 2023-1491

A RESOLUTION RECOMMENDING THAT THE PRINTING AND BINDING FOR THE ENVIRONMENT AND NATURAL RESOURCES OFFICE BE DONE THROUGH THE ALTERNATIVE MODE OF PROCUREMENT, PARTICULARLY THROUGH NEGOTIATED PROCUREMENT (SMALL VALUE PROCUREMENT) PER RULE XVI OF THE REVISED IMPLEMENTING RULES AND REGULATIONS OF REPUBLIC ACT 9184.

WHEREAS, in accordance with Section 10 of the Implementing Rules and Regulations of Republic Act 9184, as a general rule, Procuring Entities shall adopt public bidding as a general mode of procurement, however, in order to promote economy and efficiency and during exceptional cases, it may resort to alternative modes of procurement such as Negotiated Procurement as provided in Rule XVI of the said Implementing Rules;

WHEREAS, to promote economy and efficiency and to address the urgent need of the Environment and Natural Resources Office to print and bind their knowledge management and communication of HOCCI materials, the Bids and Awards Committee recommends that the procurement of the same be done through Small Value Procurement per Section 53.9 of RA 9184, considering that the amount involved which is Php 200,000.00 does not exceed the maximum amount of One Million Pesos (Php 1,000.000.00), which is the threshold for first class cities, as shown in the attached Purchase Request No.232295;

WHEREAS, on September 22, 2023, Request for Quotation was posted at the Government Electronic Procurement System (G-EPS) at the BAC Bulletin located at the New Ormoc City Hall Building, at the Superdome and the Bus Terminal, Ormoc City and sent to the following Suppliers for the Printing and Binding for the Environment and Natural Resources Office to wit;

- 1. E Garage General Merchandise
- 2. Ormoc Printshoppe
- 3. Show Graphics Design

WHEREAS, in response to the said posting and RFQ's Sent on September 28, 2023 the following Suppliers submitted their respective quotations to wit:

- 1. AG3 Colors Printing Press Php 189,950.00
- 2. SLN Printing House Php 149,900.00
- 3. Ormoc Printshoppe Php 188,000.00

WHEREAS, Ormoc Printshoppe, with business address at Aviles Street, District 3, Ormoc City, Submitted the lowest responsive price quotation among prospective suppliers with the total amount of ONE HUNDRED EIGHTY-EIGHT THOUSAND PESOS ONLY (Php 188,000.00) as shown in attached Abstract of Quotation dated September 28, 2023 as per attached evaluation report of Hector C. Salazar, BAC TWG;

On mass motion, considering the foregoing premises, be it resolved as it is hereby resolved,

THAT THE PRINTING AND BINDING FOR THE ENVIRONMENT AND NATURAL RESOURCES OFFICE BE DONE THROUGH THE ALTERNATIVE MODE OF PROCUREMENT, PARTICULARLY THROUGH NEGOTIATED PROCUREMENT (SMALL VALUE PROCUREMENT) PER RULE XVI OF THE REVISED IMPLEMENTING RULES AND REGULATIONS OF REPUBLIC ACT 9184 IN FAVOR TO ORMOC PRINTSHOPPE.
