BAC RESOLUTION NO. 2023- 1684

A RESOLUTION RECOMMENDING THAT THE LEASE OF VENUE WITH HOTEL ACCOMMODATION AND MEALS FOR THE CITY HEALTH OFFICE BE DONE THROUGH THE ALTERNATIVE MODE OF PROCUREMENT, PARTICULARLY THROUGH NEGOTIATED PROCUREMENT (SMALL VALUE PROCUREMENT) PER RULE XVI OF THE REVISED IMPLEMENTING RULES AND REGULATIONS OF REPUBLIC ACT 9184.

WHEREAS, in accordance with Section 10 of the Implementing Rules and Regulations of Republic Act 9184, as a general rule, Procuring Entities shall adopt public bidding as a general mode of procurement, however, in order to promote economy and efficiency and during exceptional cases, it may resort to alternative modes of procurement such as Negotiated Procurement as provided in Rule XVI of the said Implementing Rules;

WHEREAS, to promote economy and efficiency and to address the urgent need of the City Health Office to lease venue with hotel accommodation and meals, the Bids And Awards Committee recommends that the procurement of the same be done through Small Value Procurement per Section 53.9 of RA 9184, considering that the amount involved which is Php 403,520.00 does not exceed the maximum amount of One Million Pesos (Php 1,000.000.00), which is the threshold for first class cities, as shown in the attached Purchase Request No. 232418;

WHEREAS, on November 14, 2023 Request for Quotation was posted at the Government Electronic Procurement System (G-EPS) at the BAC Bulletin located at the New Ormoc City Hall Building, at the Superdome and the Bus Terminal, Ormoc City and sent to the following Suppliers for the Lease Venue with Hotel Accommodation and Meals for the City Health Office to wit:

- 1. Ormoc Carlosta Hotel Inc.
- 2. Asprac Agricultural Corp.
- 3. Cristobal's Inn



WHEREAS, in response to the said posting and RFQ's Sent, on November 20, 2023, only Asprac Agricultural Corporation with business address at Bonifacio Sr., Ormoc City, Submitted the lone responsive price quotation with the total amount of FOUR HUNDRED TWO THOUSAND THREE HUNDRED TWENTY PESOS ONLY (Php 402,320.00) as shown in attached Abstract of Quotation dated November 20, 2023;

On mass motion, considering the foregoing premises, be it resolved as it is hereby resolved,

THAT THE LEASE OF VENUE WITH HOTEL ACCOMMODATION AND MEALS FOR THE CITY HEALTH OFFICE BE DONE THROUGH THE ALTERNATIVE MODE OF PROCUREMENT, PARTICULARLY THROUGH NEGOTIATED PROCUREMENT (SMALL VALUE PROCUREMENT) PER RULE XVI OF THE REVISED IMPLEMENTING RULES AND REGULATIONS OF REPUBLIC ACT 9184 IN FAVOR TO ASPRAC AGRICULTURAL CORPORATION.
