**BAC RESOLUTION NO. 2023- 1760**

**A RESOLUTION RECOMMENDING THAT THE PROCUREMENT OF SAFETY VEST FOR THE CITY MAYOR'S OFFICE BE DONE THROUGH THE ALTERNATIVE MODE OF PROCUREMENT, PARTICULARLY THROUGH NEGOTIATED PROCUREMENT (SMALL VALUE PROCUREMENT) PER RULE XVI OF THE REVISED IMPLEMENTING RULES AND REGULATIONS OF REPUBLIC ACT 9184.**

**WHEREAS**, in accordance with Section 10 of the Implementing Rules and Regulations of Republic Act 9184, as a general rule, Procuring Entities shall adopt public bidding as a general mode of **procurement**, however, in order to promote economy and efficiency and during exceptional cases, it may resort to alternative modes of procurement such as Negotiated Procurement as provided in Rule XVI of the said Implementing Rules;

**WHEREAS**, to promote economy and efficiency and to address the urgent need of the **City Mayor's Office** for safety vest, the **Bids and Awards Committee** recommends that the procurement of the same be done through **Small Value Procurement per Section 53.9 of RA 9184**, considering that the amount involved which is **Php 257,250.00** does not exceed the **maximum amount of One Million Pesos (Php 1,000,000.00)**, which is the threshold for first class cities, **as shown in the attached Purchase Request No. 232671;**

**WHEREAS**, on **November 23, 2023** Request for Quotation was posted at the Government Electronic Procurement System (G-EPS) at the BAC Bulletin located at the New Ormoc City Hall Building, at the Superdome and the Bus Terminal, Ormoc City and sent to the following Suppliers for the Procurement of safety vest for the City Mayor's Office to wit:

1. Alvi Marketing
2. Majari Sales and Technical Services Inc.
3. Uni-Real Trading Corporation

**WHEREAS**, in response to the said posting and RFQ's Sent, **November 29, 2023**, the following Suppliers submitted their respective quotations to wit:

1. JM 3D Supply & Services Corp. – Php 238,000.00
2. Majari Sales and Technical Services Inc. – Php 239,750.00 -
3. Uni-Real Trading Corporation – Php 252,000.00-

**WHEREAS**, Uni-Real Trading Corporation with business address at **Osmeña St(s), District 23, Ormoc City**, Submitted the lowest responsive price quotation with the total amount of **TWO HUNDRED FIFTY-TWO THOUSAND PESOS ONLY (Php 252,000.00)** as shown in attached Abstract of Quotation dated **November 29, 2023** as per attached evaluation report of **Hector C. Salazar, BAC TWG**;
