BAC RESOLUTION NO. 2023- 1774

A RESOLUTION RECOMMENDING THAT THE SUPPLY AND DELIVERY OF LGU CALENDAR 2024 FOR THE CITY MAYOR'S OFFICE BE DONE THROUGH THE ALTERNATIVE MODE OF PROCUREMENT, PARTICULARLY THROUGH NEGOTIATED PROCUREMENT (SMALL VALUE PROCUREMENT) PER RULE XVI OF THE REVISED IMPLEMENTING RULES AND REGULATIONS OF REPUBLIC ACT 9184.

WHEREAS, in accordance with Section 10 of the Implementing Rules and Regulations of Republic Act 9184, as a general rule, Procuring Entities shall adopt public bidding as a general mode of **procurement**, however, in order to promote economy and efficiency and during exceptional cases, it may resort to alternative modes of procurement such as Negotiated Procurement as provided in Rule XVI of the said Implementing Rules;

WHEREAS, to promote economy and efficiency and to address the urgent need of the **City Mayor's Office** for LGU calendar 2024, the **Bids and Awards Committee** recommends that the procurement of the same be done through **Small Value Procurement per Section 53.9 of RA 9184**, considering that the amount involved which is **Php 999,900.00** does not exceed the **maximum amount of One Million Pesos (Php 1,000,000.00)**, which is the threshold for first class cities, **as shown in the attached Purchase Request No.232856;**

WHEREAS, on **November 28, 2023**, Request for Quotation was posted at the Government Electronic Procurement System (G-EPS) at the BAC Bulletin located at the New Ormoc City Hall Building, at the Superdome and the Bus Terminal, Ormoc City and sent to the following Suppliers for the Supply and Delivery of LGU Calendar 2024 for the City Mayor's Office to wit;

2. First Basic Digital
3. JP Colecciones

WHEREAS, in response to the said posting and RFQ's Sent, on **December 04, 2023**, the following Suppliers submitted their respective quotations to wit:

3. AG3Colors Printing Press – Php 843,000.00
4. Zurbano Publishing & Printing Corp. – Php 997,050.00

WHEREAS, E Garage General Merchandise with business address at **12J Navarro St., Ormoc City.**, Submitted the lowest responsive price quotation with the total amount of **NINE HUNDRED NINETY-NINE THOUSAND NINE HUNDRED PESOS ONLY (Php 999,900.00)** as shown in attached Abstract of Quotation dated **December 04, 2023** as per attached evaluation report of **Hector C. Salazar**;
