BAC RESOLUTION NO. 2023- 1834

A RESOLUTION RECOMMENDING THAT THE PROCUREMENT OF COMBINATION ROLLER BLINDS FOR THE CITY MAYOR'S OFFICE DONE THROUGH THE ALTERNATIVE MODE OF PROCUREMENT, PARTICULARLY THROUGH NEGOTIATED PROCUREMENT (SMALL VALUE PROCUREMENT) PER RULE XVI OF THE REVISED IMPLEMENTING RULES AND REGULATIONS OF REPUBLIC ACT 9184.

WHEREAS, in accordance with Section 10 of the Implementing Rules and Regulations of Republic Act 9184, as a general rule, Procuring Entities shall adopt public bidding as a general mode of procurement, however, in order to promote economy and efficiency and during exceptional cases, it may resort to alternative modes of procurement such as Negotiated Procurement as provided in Rule XVI of the said Implementing Rules;

WHEREAS, to promote economy and efficiency and to address the urgent need of City Mayor's Office for combination roller blinds, the Bids and Awards Committee recommends that the procurement of the same be done through Small Value Procurement per Section 53.9 of RA 9184, considering that the amount involved which is Php 100,262.25 does not exceed the maximum amount of One Million Pesos (Php 1,000.000.00), which is the threshold for first class cities, as shown in the attached Purchase Request No. 232933;

WHEREAS, on December 15, 2023, Request for Quotation was posted at the Government Electronic Procurement System (G-EPS) at the BAC Bulletin located at the New Ormoc City Hall Building, at the Superdome and the Bus Terminal, Ormoc City and sent to the following Suppliers for Procurement of Combination Roller Blinds for the City Mayor's to wit;

- 1. Andar Trading and Services
- 2. Alvi Marketing
- 3. Uni-Real Trading Corporation



WHEREAS, in response to the said posting and RFQ's Sent, on December 21, 2023 the following Suppliers submitted their respective quotations to wit:

- 1. Andar Trading and Services Php 98,000.00
- 2. A. B. Catamco Marketing & Ent. Php 72,553.00

WHEREAS, Andar Trading and Services with business address at Hermosilla Drive St(s) District 20, Ormoc City, Submitted the lowest responsive price quotation with the total amount of NINETY-EIGHT THOUSAND PESOS ONLY (Php 98,000.00) as shown in attached Abstract of Quotation dated December 21, 2023 as per attached evaluation report of Hector C. Salazar;

On mass motion, considering the foregoing premises, be it resolved as it is hereby resolved,

THAT THE PROCUREMENT OF COMBINATION ROLLER BLINDS FOR THE CITY MAYOR'S OFFICE BE DONE THROUGH THE ALTERNATIVE MODE OF PROCUREMENT, PARTICULARLY THROUGH NEGOTIATED PROCUREMENT (SMÁLL VALUE PROCUREMENT) PER RULE XVI OF THE REVISED IMPLEMENTING RULES AND REGULATIONS OF REPUBLIC ACT 9184 IN FAVOR TO ANDAR TRADING AND SERVICES.
