**BAC RESOLUTION NO. 2023- 1847**

**A RESOLUTION RECOMMENDING THAT THE SECURITY GUARD SERVICES FOR THE ORMOC CITY TOURISM OFFICE BE DONE THROUGH THE ALTERNATIVE MODE OF PROCUREMENT, PARTICULARLY THROUGH NEGOTIATED PROCUREMENT (SMALL VALUE PROCUREMENT) PER RULE XVI OF THE REVISED IMPLEMENTING RULES AND REGULATIONS OF REPUBLIC ACT 9184.**

**WHEREAS**, in accordance with Section 10 of the Implementing Rules and Regulations of Republic Act 9184, as a general rule, Procuring Entities shall adopt public bidding as a general mode of **procurement**, however, in order to promote economy and efficiency and during exceptional cases, it may resort to alternative modes of procurement such as Negotiated Procurement as provided in Rule XVI of the said Implementing Rules;

**WHEREAS**, to promote economy and efficiency and to address the urgent need of the **Ormoc City Tourism Office** for Security Guard Services, the **Bids And Awards Committee** recommends that the procurement of the same be done through **Small Value Procurement per Section 53.9 of RA 9184**, **considering** that the amount involved which is **Php 990,000.00** does not exceed the **maximum amount of One Million Pesos (Php 1,000,000.00)**, which is the threshold for first class cities, **as shown in the attached Purchase Request No. 232927;**

**WHEREAS**, on **December 21, 2023**, Request for Quotation was posted at the Government Electronic Procurement System (G-EPS) at the BAC Bulletin located at the New Ormoc City Hall Building, at the Superdome and the Bus Terminal, Ormoc City and sent to the following Suppliers for the Security Guard Services for the Ormoc City Tourism Office to wit;

1. Prac Security Agency
2. Vision Security Services Inc.
3. Red Dave Security
4. White Stone Security Agency

WHEREAS, in response to the said posting and RFQ's Sent, on **December 29, 2023**, the following Suppliers submitted their respective quotations to wit:

1. Vision Security Services Inc. – Php 948,802.40
2. Prac Security Agency – Php 982,927.68

WHEREAS, Vision Security Services Inc., with business address at Potecano Compound, Caibaan, Maharlika, Brgy. 95 Tacloban City, submitted the lowest responsive price quotation with the total amount of **NINE HUNDRED FORTY-EIGHT THOUSAND EIGHT HUNDRED TWO PESOS & 40/100 ONLY (Php 948,802.40)** as shown in attached Abstract of Quotation dated December 29, 2023 as per attached evaluation report of Hector C. Salazar, BAC TWG;
