BAC RESOLUTION NO. 2023- 1844

A RESOLUTION RECOMMENDING THAT THE RENTAL OF LIGHTS, SOUNDS AND LED WALL SCREEN FOR THE ORMOC CITY TOURISM OFFICE DONE THROUGH THE ALTERNATIVE MODE OF PROCUREMENT, PARTICULARLY THROUGH NEGOTIATED PROCUREMENT (SMALL VALUE PROCUREMENT) PER RULE XVI OF THE REVISED IMPLEMENTING RULES AND REGULATIONS OF REPUBLIC ACT 9184.

WHEREAS, in accordance with Section 10 of the Implementing Rules and Regulations of Republic Act 9184, as a general rule, Procuring Entities shall adopt public bidding as a general mode of **procurement**, however, in order to promote economy and efficiency and during exceptional cases, it may resort to alternative modes of procurement such as Negotiated Procurement as provided in Rule XVI of the said Implementing Rules;

WHEREAS, to promote economy and efficiency and to address the urgent need of **Ormoc City Tourism Office** to rent lights, sounds and led wall screen, the **Bids And Awards Committee** recommends that the procurement of the same be done through **Small Value Procurement per Section 53.9 of RA 9184**, **considering** that the amount involved which is **Php 750,000.00** does not exceed the **maximum amount of One Million Pesos (Php 1,000,000.00)**, which is the threshold for first class cities, **as shown in the attached Purchase Request No. 232930;**

WHEREAS, on **December 21, 2023**, Request for Quotation was posted at the Government Electronic Procurement System (G-EPS) at the BAC Bulletin located at the New Ormoc City Hall Building, at the Superdome and the Bus Terminal, Ormoc City and sent to the following Suppliers for the Rental of Lights, Sounds and Led Wall Screen for the Ormoc City Tourism Office to wit;

1. Eugsval Light & Sound Services
2. V Music Lights and Sounds
3. Danmar's Light and Audio Mobile

WHEREAS, in response to the RFQ's Sent **December 29, 2023**, the following Suppliers submitted their respective quotations to wit:

1. Eugsval Light & Sound Services – Php 750,000.00
2. V Music Lights and Sounds – Php 775,000.00
3. Danmar's Light and Audio Mobile – Php 800,000.00


