**BAC RESOLUTION NO. 2024-02**

**A RESOLUTION RECOMMENDING THAT THE PROCUREMENT OF GOLD MEDALS FOR THE CITY MAYOR'S OFFICE BE DONE THROUGH THE ALTERNATIVE MODE OF PROCUREMENT, PARTICULARLY THROUGH NEGOTIATED PROCUREMENT (SMALL VALUE PROCUREMENT) PER RULE XVI OF THE REVISED IMPLEMENTING RULES AND REGULATIONS OF REPUBLIC ACT 9184.**

**WHEREAS**, in accordance with Section 10 of the Implementing Rules and Regulations of Republic Act 9184, as a general rule, Procuring Entities shall adopt public bidding as a general mode of **procurement**, however, in order to promote economy and efficiency and during exceptional cases, it may resort to alternative modes of procurement such as Negotiated Procurement as provided in Rule XVI of the said Implementing Rules;

**WHEREAS**, to promote economy and efficiency and to address the urgent need of **City Mayor's Office** for gold medals, the **Bids and Awards Committee** recommends that the procurement of the same be done through **Small Value Procurement per Section 53.9 of RA 9184**, considering that the amount involved which is **Php 400,000.00** does not exceed the **maximum amount of One Million Pesos (Php 1,000,000.00)**, which is the threshold for first class cities, **as shown in the attached Purchase Request No.232962;**

**WHEREAS**, on **December 28, 2023**, Request for Quotation was posted at the Government Electronic Procurement System (G-EPS) at the BAC Bulletin located at the New Ormoc City Hall Building, at the Superdome and the Bus Terminal, Ormoc City and sent to the following Suppliers for the Procurement of gold Medals for the City Mayors Office to wit:

1. Gift of God Engraving Services
2. HAP Metal Fabricators
3. MLDB Printing Services



WHEREAS, in response to the said posting and RFQ's Sent, on January 02, 2024 the following Suppliers submitted their respective quotations to wit:

1. Gift of God Engraving Services – Php 400,000.00
2. Brabeus Trading – Php 328,00.00
3. MLDB Printing Services – Php 500,000.00
4. Deus Ent. Co. – Php 300,000.00

WHEREAS, Gift of God Engraving Services, with business address at Lot 10319-D, Ylaya St., Talamban, Cebu City, Submitted the lowest responsive price quotation among prospective suppliers with the total amount of **FOUR HUNDRED THOUSAND PESOS ONLY (Php 400,000.00)** as shown in attached Abstract of Quotation dated January 02, 2024 and per attached Evaluation Report of Hector C. Salazar, BAC TWG;

On mass motion, considering the foregoing premises, be it resolved as it is hereby resolved,
