**BAC RESOLUTION NO. 2024-011**

**A RESOLUTION RECOMMENDING THAT THE NEWSPAPER ADVERTISING OF THE CITY MAYOR'S OFFICE BE DONE THROUGH THE ALTERNATIVE MODE OF PROCUREMENT, PARTICULARLY THROUGH NEGOTIATED PROCUREMENT (SMALL VALUE PROCUREMENT) PER RULE XVI OF THE REVISED IMPLEMENTING RULES AND REGULATIONS OF REPUBLIC ACT 9184.**

**WHEREAS**, in accordance with Section 10 of the Implementing Rules and Regulations of Republic Act 9184, as a general rule, Procuring Entities shall adopt public bidding as a general mode of **procurement**, however, in order to promote economy and efficiency and during exceptional cases, it may resort to alternative modes of procurement such as Negotiated Procurement as provided in Rule XVI of the said Implementing Rules;

**WHEREAS**, to promote economy and efficiency and to address the urgent need of the **City Mayor's Office** for newspaper advertising, the **Bids And Awards Committee** recommends that the procurement of the same be done through **Small Value Procurement per Section 53.9 of RA 9184**, **considering** that the amount involved which is **Php 450,000.00** does not exceed the **maximum amount of One Million Pesos (Php 1,000,000.00)**, which is the threshold for first class cities, **as shown in the attached Purchase Request No. 232949;**

**WHEREAS**, on **December 28 2023**, Request for Quotation was posted at the Government Electronic Procurement System (G-EPS) at the BAC Bulletin located at the New Ormoc City Hall Building, at the Superdome and the Bus Terminal, Ormoc City and sent to the following newspaper advertising of the City Mayor's Office to wit;

2. Krusada Balita News Publishing Services
3. Balita Tirador (Balita 8)

**WHEREAS**, in response to the said posting and RFQ's Sent, on **January 04, 2024** the following Suppliers submitted their respective quotations to wit:

1. Eastern Visayas Mail – Php 500,00.00
2. Krusada Balita News Publishing Services – Php 450,000.00
3. Balita Tirador (Balita 8) – Php 500,00.00

**WHEREAS**, Krusada Balita News Publishing Services, with business address at 2/F Pro Deo et Patria Bldg. J. Navarro St. (s) District 9, Ormoc City, submitted the lowest responsive price quotation among prospective suppliers with the total amount of **FOUR HUNDRED FIFTY THOUSAND PESOS ONLY (Php 450,000.00)** as shown in attached **Abstract of Quotation** dated **January 04, 2024**;
