BAC RESOLUTION NO. 2024-028

A RESOLUTION RECOMMENDING THAT THE PHOTO AND VIDEO COVERAGE SERVICES OF THE CITY MAYOR'S OFFICE BE DONE THROUGH THE ALTERNATIVE MODE OF PROCUREMENT, PARTICULARLY THROUGH NEGOTIATED PROCUREMENT (SMALL VALUE PROCUREMENT) PER RULE XVI OF THE REVISED IMPLEMENTING RULES AND REGULATIONS OF REPUBLIC ACT 9184.

WHEREAS, in accordance with Section 10 of the Implementing Rules and Regulations of Republic Act 9184, as a general rule, Procuring Entities shall adopt public bidding as a general mode of **procurement**, however, in order to promote economy and efficiency and during exceptional cases, it may resort to alternative modes of procurement such as Negotiated Procurement as provided in Rule XVI of the said Implementing Rules;

WHEREAS, to promote economy and efficiency and to address the urgent need of the **City Mayor's Office** for photo and video coverage Services, the **Bids and Awards Committee** recommends that the procurement of the same be done through **Small Value Procurement per Section 53.9 of RA 9184**, **considering** that the amount involved which is **Php 500,000.00** does not exceed the **maximum amount of One Million Pesos (Php 1,000,000.00)**, which is the threshold for first class cities, **as shown in the attached Purchase Request No. 232947;**

WHEREAS, on **January 04, 2024**, Request for Quotation was posted at the Government Electronic Procurement System (G-EPS) at the BAC Bulletin located at the New Ormoc City Hall Building, at the Superdome and the Bus Terminal, Ormoc City and sent to the following Suppliers for the Photo and video coverage Services of the City Mayor's Office to wit;

1. ✓ Elite Marketing
2. ✓ Jude Photography
3. ✓ Nanu Production

WHEREAS, in response to the said posting and RFQ's Sent on **January 10, 2024** the following Suppliers submitted their respective quotations to wit:

1. Elite Marketing – Php 500,000.00
2. Nanu Production – Php 520,000.00
3. Jude Photography – Php 510,000.00
4. Semper-Films Photography & Videography Services – Php 350,000.00

WHEREAS, Elite Marketing, with business address at Bonifacio St., District 09, Ormoc City, submitted the lowest responsive price quotation among prospective suppliers with the total amount of **FIVE HUNDRED THOUSAND PESOS ONLY (Php 500,000.00)** as shown in attached **Abstract of Quotation** dated **January 10, 2024** as per attached evaluation report of Mr. Hector C. Salazar, BAC TWG;
