BAC RESOLUTION NO. 2024-043

A RESOLUTION RECOMMENDING THAT THE PROCUREMENT OF PLANE AND BOAT TICKETS FOR THE ORMOC CITY TOURISM OFFICE DONE THROUGH THE ALTERNATIVE MODE OF PROCUREMENT, PARTICULARLY THROUGH NEGOTIATED PROCUREMENT (SMALL VALUE PROCUREMENT) PER RULE XVI OF THE REVISED IMPLEMENTING RULES AND REGULATIONS OF REPUBLIC ACT 9184.

WHEREAS, in accordance with Section 10 of the Implementing Rules and Regulations of Republic Act 9184, as a general rule, Procuring Entities shall adopt public bidding as a general mode of procurement, however, in order to promote economy and efficiency and during exceptional cases, it may resort to alternative modes of procurement such as Negotiated Procurement as provided in Rule XVI of the said Implementing Rules;

WHEREAS, to promote economy and efficiency and to address the urgent need of Ormoc City Tourism office for plane and boat tickets, the Bids and Awards Committee recommends that the procurement of the same be done through Small Value Procurement per Section 53.9 of RA 9184, considering that the amount involved which is Php 850,000.00 does not exceed the maximum amount of One Million Pesos (Php 1,000.000.00), which is the threshold for first class cities, as shown in the attached Purchase Request No. 232931;

WHEREAS, on January 09, 2024 Request for Quotation was posted at the Government Electronic Procurement System (G-EPS) at the BAC Bulletin located at the New Ormoc City Hall Building, at the Superdome and the Bus Terminal, Ormoc City and sent to the following Suppliers for the Procurement of plane and boat tickets for the Ormoc City Tourism office to wit:

- 1. 3K Giants Travel and Tours Inc.
- 2. Isabela Travels
- 3. CG Tours and Travel Services



WHEREAS, in response to the said posting and RFQ's Sent, on January 15, 2024 the following Suppliers submitted their respective quotations to wit:

- 1. 3k Giants Travel & Tours Php 850,000.00
- 2. Isabela Travels Php 1,000,000.00
- 3. CG Tours & travel Services Php 1,100,000.00

WHEREAS, 3K Giants Travel and Tours Inc., with business address at St. Jude Building, Real Street Barangay 14, Ormoc City, submitted the lowest responsive price quotation with the total amount of EIGHT HUNDRED FIFTY THOUSAND PESOS ONLY (Php 850,000.00) as shown in attached Abstract of Quotation dated January 15, 2024;

On mass motion, considering the foregoing premises, be it resolved as it is hereby resolved,

THAT THE PROCUREMENT OF PLANE AND BOAT TICKETS FOR THE ORMOC CITY TOURISM OFFICE BE DONE THROUGH THE ALTERNATIVE MODE OF PROCUREMENT, PARTICULARLY THROUGH NEGOTIATED PROCUREMENT (SMALL VALUE PROCUREMENT) PER RULE XVI OF THE REVISED IMPLEMENTING RULES AND REGULATIONS OF REPUBLIC ACT 9184 IN FAVOR TO 3K GIANTS TRAVEL AND TOURS INC.
