**BAC RESOLUTION NO. 2024-049**

**A RESOLUTION RECOMMENDING THAT THE PROCUREMENT OFFICE SUPPLIES FOR THE ORMOC CITY TOURISM OFFICE BE DONE THROUGH THE ALTERNATIVE MODE OF PROCUREMENT, PARTICULARLY THROUGH SHOPPING PER RULE XVI OF THE REVISED IMPLEMENTING RULES AND REGULATIONS OF REPUBLIC ACT 9184.**

**WHEREAS**, in accordance with Section 10 of the Implementing Rules and Regulations of Republic Act 9184, as a general rule, Procuring Entities shall adopt public bidding as a general mode of **procurement**, however, in order to promote economy and efficiency and during exceptional cases, it may resort to alternative modes of procurement such as Negotiated Procurement as provided in Rule XVI of the said Implementing Rules;

**WHEREAS**, to promote economy and efficiency and to address the urgent need of the **Ormoc City Tourism Office** for Office supplies, the **Bids and Awards Committee** recommends that the procurement of the same be done through **Shopping per Section 52.1.b of RA 9184**, considering that the amount involved which is **Php 267,120.00** does not exceed the **maximum amount of One Million Pesos (Php 1,000,000.00)**, which is the threshold for first class cities, **as shown in the attached Purchase Request No. 240034;**

**WHEREAS**, the aforementioned supplies and materials are not available at the Procurement Service Tacloban Regional Depot as per attached Tacloban List of Common-Use Supplies and Equipment of Philippine Government Electronic Procurement System;

**WHEREAS**, on **January 12, 2024**, Request for Quotation was posted at the Government Electronic Procurement System (G-EPS) at the BAC Bulletin located at the New Ormoc City Hall Building, at the Superdome and the Bus Terminal, Ormoc City and sent to the following Suppliers for the Procurement of Office supplies for the Ormoc City Tourism Office to wit;

1. ✓ Fabulous Enterprises
2. ✓ OK. Gen Merchandise
3. ✓ Victoria Global Ventures

WHEREAS, in response to the said posting of RFQ's Sent on January 18, 2024, the following Suppliers submitted their respective quotations to wit:

1. Fabulous Enterprises – Php 393,545.00 ✓
2. Victoria Global Ventures – Php 267,070.00 ✓
3. OK. Gen Merchandise – Php 354,070.00 ✓

WHEREAS, Victoria Global Ventures, with business address at Brgy. Naga-naga, Palo Leyte, submitted the lowest responsive price quotation among prospective suppliers with the total amount of TWO HUNDRED SIXTY-SEVEN THOUSAND SEVENTY PESOS ONLY (Php 267,070.00) as shown in attached Abstract of Quotation dated January 18, 2024;


On mass motion, considering the foregoing premises, be it resolved as it is hereby resolved,
