## BAC RESOLUTION NO. 2024-082

A RESOLUTION RECOMMENDING THAT THE PHOTO DOCUMENTATION SERVICES OF THE CITY MAYOR'S OFFICE BE DONE THROUGH THE ALTERNATIVE MODE OF PROCUREMENT, PARTICULARLY THROUGH NEGOTIATED PROCUREMENT (SMALL VALUE PROCUREMENT) PER RULE XVI OF THE REVISED IMPLEMENTING RULES AND REGULATIONS OF REPUBLIC ACT 9184.

WHEREAS, in accordance with Section 10 of the Implementing Rules and Regulations of Republic Act 9184, as a general rule, Procuring Entities shall adopt public bidding as a general mode of procurement, however, in order to promote economy and efficiency and during exceptional cases, it may resort to alternative modes of procurement such as Negotiated Procurement as provided in Rule XVI of the said Implementing Rules;

WHEREAS, to promote economy and efficiency and to address the urgent need of the City Mayor's Office for photo documentation Services, the Bids and Awards Committee recommends that the procurement of the same be done through Small Value Procurement per Section 53.9 of RA 9184, considering that the amount involved which is Php 657,800.00 does not exceed the maximum amount of One Million Pesos (Php 1,000.000.00), which is the threshold for first class cities, as shown in the attached Purchase Request No. 240195;

WHEREAS, on January 24, 2024, Request for Quotation was posted at the Government Electronic Procurement System (G-EPS) at the BAC Bulletin located at the New Ormoc City Hall Building, at the Superdome and the Bus Terminal, Ormoc City and sent to the following Suppliers for the Photo and Documentation Services of the City Mayor's Office to wit;

- 1. Elite Marketing
- 2. Jude Photography
- 3. Nanu Production

WHEREAS, in response to the said posting and RFQ's Sent on January 30, 2024 the following Suppliers submitted their respective quotations to wit:

- 1. Elite Marketing Php 657,800.00
- 2. Nanu Production Php 665,000.00
- 3. Jude Photography Php 700,000.00

WHEREAS, Elite Marketing, with business address at Bonifacio St., District 09, Ormoc City, submitted the lowest responsive price quotation among prospective suppliers with the total amount of SIX HUNDRED FIFTY-SEVEN THOUSAND EIGHT HUNDRED PESOS ONLY (Php 657,800.00) as shown in attached Abstract of Quotation dated January 30, 2024;

On mass motion, considering the foregoing premises, be it resolved as it is hereby resolved,
