BAC RESOLUTION NO. 2024-113

A RESOLUTION RECOMMENDING THAT THE PROCUREMENT OF SLAP TATOOER INK AND CARTRIDGE STUNNER BULLET FOR THE ORMOC SLAUGHTERHOUSE BE DONE THROUGH THE ALTERNATIVE MODE OF PROCUREMENT, PARTICULARLY THROUGH NEGOTIATED PROCUREMENT (SMALL VALUE PROCUREMENT) PER RULE XVI OF THE REVISED IMPLEMENTING RULES AND REGULATIONS OF REPUBLIC ACT 9184.

WHEREAS, in accordance with Section 10 of the Implementing Rules and Regulations of Republic Act 9184, as a general rule, Procuring Entities shall adopt public bidding as a general mode of **procurement**, however, in order to promote economy and efficiency and during exceptional cases, it may resort to alternative modes of procurement such as Negotiated Procurement as provided in Rule XVI of the said Implementing Rules;

WHEREAS, to promote economy and efficiency and to address the urgent need of the **Ormoc Slaughterhouse** of slap tatoer Ink and cartridge stunner bullet for tattoing livestock animals and matanza of City Slaughterhouse, the **Bids and Awards Committee** recommends that the procurement of the same be done through **Small Value Procurement per Section 53.9 of RA 9184**, considering that the amount involved which is **Php 74,000.00** does not exceed the **maximum amount of One Million Pesos (Php 1,000,000.00)**, which is the threshold for first class cities, **as shown in the attached Purchase Request No. 240304;**

WHEREAS, on **January 26, 2024**, Request for Quotation was posted at the Government Electronic Procurement System (G-EPS) at the BAC Bulletin located at the New Ormoc City Hall Building, at the Superdome and the Bus Terminal, Ormoc City and sent to the following Suppliers for Procurement of Slap Tatoer Ink and Cartridge Stunner Bullet for the Ormoc Slaughterhouse to wit;

1. Shift Tech Trading Inc.
2. Alvi Marketing
3. Pito Enterprises

WHEREAS, in response to the said posting and RFQ's Sent, on February 01, 2024, only **System Processor & Construction Corp.** with business address at **B3 L25/26 MT Caraballo Drive, Nova Hills Subd. Bagumbong, Brgy. 171 Dist. 1, Caloocan City** submitted the lone responsive price quotation among prospective suppliers with the total amount of **SEVENTY-THREE THOUSAND FIVE HUNDRED PESOS ONLY (Php 73,500.00)** as shown in attached **Abstract of Quotation February 01, 2024;**


On mass motion, considering the foregoing premises, be it resolved as it is hereby resolved,
