BAC RESOLUTION NO. 2024-108

A RESOLUTION RECOMMENDING THAT THE SUPPLY AND INSTALLATION OF AIRCONDITIONING UNITS FOR THE CITY CIVIL REGISTRAR BE DONE THROUGH THE ALTERNATIVE MODE OF PROCUREMENT, PARTICULARLY THROUGH NEGOTIATED PROCUREMENT (SMALL VALUE PROCUREMENT) PER RULE XVI OF THE REVISED IMPLEMENTING RULES AND REGULATIONS OF REPUBLIC ACT 9184.

WHEREAS, in accordance with Section 10 of the Implementing Rules and Regulations of Republic Act 9184, as a general rule, Procuring Entities shall adopt public bidding as a general mode of **procurement**, however, in order to promote economy and efficiency and during exceptional cases, it may resort to alternative modes of procurement such as Negotiated Procurement as provided in Rule XVI of the said Implementing Rules;

WHEREAS, to promote economy and efficiency and to address the urgent need of the City Civil Registrar for airconditioning units, the Bids and Awards Committee recommends that the procurement of the same be done through Small Value Procurement per Section 53.9 of RA 9184, considering that the amount involved which is Php 450,000.00 does not exceed the maximum amount of One Million Pesos (Php 1,000.000.00), which is the threshold for first class cities, as shown in the attached Purchase Request No. 240338;

WHEREAS, on January 26, 2024, Request for Quotation was posted at the Government Electronic Procurement System (G-EPS) at the BAC Bulletin located at the New Ormoc City Hall Building, at the Superdome and the Bus Terminal, Ormoc City and sent to the following Suppliers for Supply and Installation of Airconditioning Units for the City Civil Registra to wit;

- 1. Paramount Trading
- 2. Tac Sam's Trading
- 3. Bhagat Emporium

WHEREAS, in response to the said posting and RFQ's Sent, on February 01, 2024 the following Suppliers submitted their respective quotations to wit:

- 1. Paramount Trading Php 449,000.00
- 2. Tac Sam's Trading Php 450,000.00
- 3. Bhagat Emporium Php 449,500.00
- 4. Compuspec Sales & Services Php 360,000.00

WHEREAS, Paramount Trading with business address at Lot 13 block 3 NHA, Baras, Palo, Leyte., submitted the lowest responsive price quotation among prospective suppliers with the total amount of FOUR HUNDRED FORTY-NINE THOUSAND PESOS ONLY (Php 449,000.00) as shown in attached Abstract of Quotation February 01, 2024 and per attached Evaluation Report of Dexter b. Jumao-as, BAC TWG dated February 02, 2024;

On mass motion, considering the foregoing premises, be it resolved as it is hereby resolved,
