BAC RESOLUTION NO. 2024-102

A RESOLUTION RECOMMENDING THAT THE PROCUREMENT OF NETWORKING DEVICES/ACCESSORIES FOR THE CITY PLANNING AND DEVELOPMENT OFFICE DONE THROUGH THE ALTERNATIVE MODE OF PROCUREMENT, PARTICULARLY THROUGH NEGOTIATED PROCUREMENT (SMALL VALUE PROCUREMENT) PER RULE XVI OF THE REVISED IMPLEMENTING RULES AND REGULATIONS OF REPUBLIC ACT 9184.

WHEREAS, in accordance with Section 10 of the Implementing Rules and Regulations of Republic Act 9184, as a general rule, Procuring Entities shall adopt public bidding as a general mode of **procurement**, however, in order to promote economy and efficiency and during exceptional cases, it may resort to alternative modes of procurement such as Negotiated Procurement as provided in Rule XVI of the said Implementing Rules;

WHEREAS, to promote economy and efficiency and to address the urgent need of **City Planning and Development Office** for networking devices/accessories, the **Bids And Awards Committee** recommends that the procurement of the same be done through **Small Value Procurement per Section 53.9 of RA 9184, considering** that the amount involved which is **Php 799,900.00** does not exceed the **maximum amount of One Million Pesos (Php 1,000,000.00)**, which is the threshold for first class cities, **as shown in the attached Purchase Request No. 240291;**

WHEREAS, On **January 26, 2024**, Request for Quotation was posted at the Government Electronic Procurement System (G-EPS) at the BAC Bulletin located at the New Ormoc City Hall Building, at the Superdome and the Bus Terminal, Ormoc City and sent to the following Suppliers for Procurement of networking devices/accessories for the City Planning and Development Office to wit;

1. Teledatcom Phils. Inc.
2. BM Technologies Networks and Data Solution
3. REBC Lancom

WHEREAS, in response to the RFQ's Sent, on **February 01, 2024** the following Suppliers submitted their respective quotations to wit:

1. Teledatcom Phils. Inc. – Php 799,900.00
2. BM Technologies Networks and Data Solution – Php 1,100,000.00
3. REBC Lancom – Php 1,300,000.00

WHEREAS, Teledatcom Phil., Inc. with business address at **Unit 1702 Hanston Square Bldg. San Miguel Ave., Ortigas Center, San Antonio, Pasig City**, Submitted the lowest responsive price quotation with the total amount of **SEVEN HUNDRED NINETY-NINE THOUSAND NINE HUNDRED PESOS ONLY (Php 799,900.00)** as shown in attached Abstract of Quotation dated **February 01, 2024** as per attached evaluation report of **Mr. Melchizedec M. Yap, BAC TWG** dated **February 16, 2024**;
