BAC RESOLUTION NO. 2024-167

A RESOLUTION RECOMMENDING THAT THE RENTAL OF LIGHTS AND SOUNDS FOR THE CITY MAYOR'S OFFICE BE DONE THROUGH THE ALTERNATIVE MODE OF PROCUREMENT, PARTICULARLY THROUGH NEGOTIATED PROCUREMENT (SMALL VALUE PROCUREMENT) PER RULE XVI OF THE REVISED IMPLEMENTING RULES AND REGULATIONS OF REPUBLIC ACT 9184.

WHEREAS, in accordance with Section 10 of the Implementing Rules and Regulations of Republic Act 9184, as a general rule, Procuring Entities shall adopt public bidding as a general mode of **procurement**, however, in order to promote economy and efficiency and during exceptional cases, it may resort to alternative modes of procurement such as Negotiated Procurement as provided in Rule XVI of the said Implementing Rules;

WHEREAS, to promote economy and efficiency and to address the urgent need of the **City Mayor's Office** for lights and sounds, the **Bids and Awards Committee** recommends that the procurement of the same be done through **Small Value Procurement per Section 53.9 of RA 9184**, considering that the amount involved which is **Php 600,000.00** does not exceed the **maximum amount of One Million Pesos (Php 1,000,000.00)**, which is the threshold for first class cities, **as shown in the attached Purchase Request No. 240450;**

WHEREAS, on **February 07, 2024**, Request for Quotation was posted at the Government Electronic Procurement System (G-EPS) at the BAC Bulletin located at the New Ormoc City Hall Building, at the Superdome and the Bus Terminal, Ormoc City and sent to the following Suppliers for Rental of lights and sounds for the City Mayor's Office, to wit;

1. ✓ MGCP
2. ✓ JVS Audio System
3. ✓ Gensan MBE Enterprises Inc.

WHEREAS, in response to the said posting and RFQ's Sent, on February 13, 2024 the following Suppliers submitted their respective quotations to wit:

1. ✓ MGCP – Php 600,000.00
2. ✓ JVS Audio System – Php 600,000.00
3. ✓ Gensan MBE Enterprises Inc. – Php 598,000.00

WHEREAS, Gensan MBE Enterprises Inc., with business address at 4th street Manansala Subdivision, San Isidro, General Santos City, South Cotabato, submitted the lowest responsive price quotation among prospective suppliers with the total amount of FIVE HUNDRED NINETY-EIGHT THOUSAND PESOS ONLY (Php 598,000.00) as shown in attached Abstract of Quotation February 13, 2024;
