BAC RESOLUTION NO. 2024-196

A RESOLUTION RECOMMENDING THAT THE PROCUREMENT OF T-SHIRTS WITH PRINT FOR THE CITY OF THE CITY OF THE ALTERNATIVE MODE OF PROCUREMENT, PARTICULARLY THROUGH NEGOTIATED PROCUREMENT (SMALL VALUE PROCUREMENT) PER RULE XVI OF THE REVISED IMPLEMENTING RULES AND REGULATIONS OF REPUBLIC ACT 9184.

WHEREAS, in accordance with Section 10 of the Implementing Rules and Regulations of Republic Act 9184, as a general rule, Procuring Entities shall adopt public bidding as a general mode of **procurement**, however, in order to promote economy and efficiency and during exceptional cases, it may resort to alternative modes of procurement such as Negotiated Procurement as provided in Rule XVI of the said Implementing Rules;

WHEREAS, to promote economy and efficiency and to address the urgent need of the City Health - Office for t-shirts with print, the Bids and Awards Committee recommends that the procurement of the same be done through Small Value Procurement per Section 53.9 of RA 9184, considering that the amount involved which is Php 78,650.00 does not exceed the maximum amount of One Million Pesos (Php 1,000.000.00), which is the threshold for first class cities, as shown in the attached Purchase Request No.240597;

WHEREAS, on February 07, 2024, Request for Quotation was posted at the Government Electronic Procurement System (G-EPS) at the BAC Bulletin located at the New Ormoc City Hall Building, at the Superdome and the Bus Terminal, Ormoc City and sent to the following Suppliers for the procurement of t-shirts with print for the City Health Office to wit:

- 2. Ormoc Printshoppe
- 3. Show Graphics Design -

WHEREAS, in response to the said posting and RFQ's Sent, on February 13, 2024 the following Suppliers submitted their respective quotations to wit:

- 1. E Garage General Merchandise Php 78,650.00
- 2. Ormoc Printshoppe Php 78,650.00
- 3. Seaweed International Exports Inc. Php 34,122.00

WHEREAS, both E Garage General Merchandise and Ormoc Printshoppe submitted the same price quotation, thus a "toss coin" was held to determine the winning bidder

WHEREAS, E Garage General Merchandise with business address at J Navarro St., Ormoc City., Submitted the lowest responsive price quotation with the total amount of SEVENTY-EIGHT THOUSAND SIX HUNDRED FIFTY PESOS ONLY (Php 78,650.00) as shown in attached Abstract of Quotation dated February 13, 2024 as per attached evaluation report of Mr. Hector C. Salazar, BAC TWG:
