BAC RESOLUTION NO. 2024-171

A RESOLUTION RECOMMENDING THAT THE RENTAL OF LED WALL SCREEN OF THE CITY MAYOR'S OFFICE BE DONE THROUGH THE ALTERNATIVE MODE OF PROCUREMENT, PARTICULARLY THROUGH NEGOTIATED PROCUREMENT (SMALL VALUE PROCUREMENT) PER RULE XVI OF THE REVISED IMPLEMENTING RULES AND REGULATIONS OF REPUBLIC ACT 9184.

WHEREAS, in accordance with Section 10 of the Implementing Rules and Regulations of Republic Act 9184, as a general rule, Procuring Entities shall adopt public bidding as a general mode of **procurement**, however, in order to promote economy and efficiency and during exceptional cases, it may resort to alternative modes of procurement such as Negotiated Procurement as provided in Rule XVI of the said Implementing Rules;

WHEREAS, to promote economy and efficiency and to address the urgent need of the **City Mayor's Office** for LED Wall Screen, the **Bids and Awards Committee** recommends that the procurement of the same be done through **Small Value Procurement per Section 53.9 of RA 9184**, considering that the amount involved which is **Php 280,000.00** does not exceed the **maximum amount of One Million Pesos (Php 1,000,000.00)**, which is the threshold for first class cities, **as shown in the attached Purchase Request No. 240511;**

WHEREAS, on **February 07, 2024**, Request for Quotation was posted at the Government Electronic Procurement System (G-EPS) at the BAC Bulletin located at the New Ormoc City Hall Building, at the Superdome and the Bus Terminal, Ormoc City and sent to the following Suppliers for the Rental of LED Wall Screen of the City Mayor's Office to wit;

2. ✓ Music Pro electronics
3. ✓ Triple A Enterprises

WHEREAS, in response to the said posting of RFQ's Sent, on **February 13, 2024** the following Suppliers submitted their respective quotations to wit:

1. ✓ Jonard's Mobile Sound System – Php 280,000.00
2. ✓ Music Pro Electronics – Php 281,020.00
3. ✓ Triple A Enterprises– Php 282,000.00

WHEREAS, Jonard's Mobile Sound System, with business address at, Phase 6, Block 10, Lot 13 Pearl St., V&G Subd., Tacloban City submitted the lowest responsive price quotation with the total amount of **TWO HUNDRED EIGHTY THOUSAND PESOS ONLY (Php 280,000.00)** as shown in attached Abstract of Quotation dated February 13, 2024;
