BAC RESOLUTION NO. 2024-170

A RESOLUTION RECOMMENDING THAT THE HOTEL ACCOMMODATION WITH MEALS FOR THE CITY MAYOR'S OFFICE BE DONE THROUGH THE ALTERNATIVE MODE OF PROCUREMENT, PARTICULARLY THROUGH NEGOTIATED PROCUREMENT (SMALL VALUE PROCUREMENT) PER RULE XVI OF THE REVISED IMPLEMENTING RULES AND REGULATIONS OF REPUBLIC ACT 9184.

WHEREAS, in accordance with Section 10 of the Implementing Rules and Regulations of Republic Act 9184, as a general rule, Procuring Entities shall adopt public bidding as a general mode of procurement, however, in order to promote economy and efficiency and during exceptional cases, it may resort to alternative modes of procurement such as Negotiated Procurement as provided in Rule XVI of the said Implementing Rules;

WHEREAS, to promote economy and efficiency and to address the urgent need of the City Mayor's Office for hotel accommodation with meal, the Bids and Awards Committee recommends that the procurement of the same be done through Small Value Procurement per Section 53.9 of RA 9184, considering that the amount involved which is Php 179,000.00 does not exceed the maximum amount of One Million Pesos (Php 1,000.000.00), which is the threshold for first class cities, as shown in the attached Purchase Request No. 240561;

WHEREAS, on February 07, 2024 Request for Quotation was posted at the Government Electronic Procurement System (G-EPS) at the BAC Bulletin located at the New Ormoc City Hall Building, at the Superdome and the Bus Terminal, Ormoc City and sent to the following Hotel Accommodation with Meals for the City Mayor's Office to wit:

- 1. Ormoc Carlosta Hotel Inc.
- 2. Asprac Agriculture Corp.
- 3. Cristobal's Inn

WHEREAS, in response to the said posting and RFQ's Sent, on February 13, 2024, only Ormoc Carlosta Hotel Inc. with business address at Palo-Carigara-Ormoc City Rd Combado, Brgy. Cogon, Ormoc City, Submitted the lone responsive price quotation with the total amount of ONE HUNDRED SEVENTY-NINE THOUSAND PESOS ONLY (Php 179,000.00) as shown in attached Abstract of Quotation dated February 13, 2024;
