BAC RESOLUTION NO. 2024-186

A RESOLUTION RECOMMENDING THAT THE PROVISION OF MATERIALS FOR THE PREVENTIVE MAINTENANCE OF STREETLIGHTING AND DECORATIVE LAMP IN VARIOUS BARANGAYS OF ORMOC CITY, PROVISION FOR THE INSTALLATION OF ADDITIONAL LED DOWNLIGHTS (STAIRS AND OTHER OFFICES) AT NEW CITY HALL BUILDING., PROVISION OF MATERIALS FOR THE REPAIR AND MAINTENANCE OF LED LIGHTINGS OF COVERED COURTS IN VARIOUS BARANGAYS OF ORMOC CITY FOR THE CITY GENERAL SERVICES OFFICE BE DONE THROUGH THE ALTERNATIVE MODE OF PROCUREMENT, PARTICULARLY THROUGH NEGOTIATED PROCUREMENT (SMALL VALUE PROCUREMENT) PER RULE XVI OF THE REVISED IMPLEMENTING RULES AND REGULATIONS OF REPUBLIC ACT 9184.

WHEREAS, in accordance with Section 10 of the Implementing Rules and Regulations of Republic Act 9184, as a general rule, Procuring Entities shall adopt public bidding as a general mode of **procurement**, however, in order to promote economy and efficiency and during exceptional cases, it may resort to alternative modes of procurement such as Negotiated Procurement as provided in Rule XVI of the said Implementing Rules;

WHEREAS, to promote economy and efficiency and to address the urgent need of the **City General Services Office** for the provision of materials for the preventive maintenance of streetlighting and decorative lamp in various barangays of Ormoc City, provision for the installation of additional led downlights (stairs and other offices) at new city hall building., provision of materials for the repair and maintenance of led lightings of covered courts in various barangays of Ormoc City, the **Bids and Awards Committee** recommends that the procurement of the same be done through **Small Value Procurement per Section 53.9 of RA 9184, considering** that the amount involved which is **Php 736,250.00** does not exceed the **maximum amount of One Million Pesos (Php 1,000,000.00)**, which is the threshold for first class cities, **as shown in the attached Purchase Request No. 240484;**

WHEREAS, on **February 07, 2024**, Request for Quotation was posted at the Government Electronic Procurement System (G-EPS) at the BAC Bulletin located at the New Ormoc City Hall Building, at the Superdome and the Bus Terminal, Ormoc City and sent to the following Suppliers for the Provision of materials for the preventive maintenance of streetlighting and decorative lamp in various barangays of Ormoc City, provision for the installation of additional led downlights (stairs and other offices) at new city hall building., provision of materials for the repair and maintenance of led lightings of covered courts in various barangays of Ormoc City for the City General Services Office to wit;

WHEREAS, Bacolod republic Hardware Inc., with business address at Bonifacio Street, Bacolod City Negros Occidental, Negros Island Region, submitted the lowest responsive price quotation with the total amount of SEVEN HUNDRED TWENTY-SIX THOUSAND ONE HUNDRED SEVENTY-FIVE PESOS ONLY (Php 726,175.00) as shown in attached Abstract of Quotation dated February 13, 2024;
