**BAC RESOLUTION NO. 2024-177**

**A RESOLUTION RECOMMENDING THAT THE PROCUREMENT OF MEDICAL AND SURGICAL SUPPLIES FOR THE CITY VETERINARY'S OFFICE BE DONE THROUGH THE ALTERNATIVE MODE OF PROCUREMENT, PARTICULARLY THROUGH NEGOTIATED PROCUREMENT (SMALL VALUE PROCUREMENT) PER RULE XVI OF THE REVISED IMPLEMENTING RULES AND REGULATIONS OF REPUBLIC ACT 9184.**

**WHEREAS**, in accordance with Section 10 of the Implementing Rules and Regulations of Republic Act 9184, as a general rule, Procuring Entities shall adopt public bidding as a general mode of **procurement**, however, in order to promote economy and efficiency and during exceptional cases, it may resort to alternative modes of procurement such as Negotiated Procurement as provided in Rule XVI of the said Implementing Rules;

**WHEREAS**, to promote economy and efficiency and to address the urgent need of the **City Veterinary's Office** for medical and surgical supplies, the **Bids and Awards Committee** recommends that the procurement of the same be done through **Small Value Procurement per Section 53.9 of RA 9184**, considering that the amount involved which is **Php 801,500.00** does not exceed the **maximum amount of One Million Pesos (Php 1,000,000.00)**, which is the threshold for first class cities, as shown in the attached **Purchase Request No. 240580**;

**WHEREAS**, on **February 07, 2024**, Request for Quotation was posted at the Government Electronic Procurement System (G-EPS) at the BAC Bulletin located at the New Ormoc City Hall Building, at the Superdome and the Bus Terminal, Ormoc City and sent to the following Suppliers for Procurement of Medical and Surgical Supplies for the City Veterinary's Office to wit;

1. Lifeshield Pharmatrade
2. Innocare Pharma & Medical Supplies
3. Med Captain Marketing

WHEREAS, in response to the said posting and RFQ's Sent, on **February 13, 2024** the following Suppliers submitted their respective quotations to wit:

1. Lifeshield Pharmatrade – Php 800,550.00
2. Innocare Pharma & Medical Supplies – Php 801,390.00
3. Med Captain Marketing – Php 801,000.00

WHEREAS, Lifeshield Pharmatrade, with business address at Lot 13 Block 3 NHA, Baras, Palo, Leyte submitted the lowest responsive price quotation among prospective suppliers with the total amount of **EIGHT HUNDRED THOUSAND FIVE HUNDRED FIFTY PESOS ONLY (Php 800,550.00)** as shown in attached **Abstract of Quotation February 13, 2024;**


On mass motion, considering the foregoing premises, be it resolved as it is hereby resolved,
