BAC RESOLUTION NO. 2024-264

A RESOLUTION RECOMMENDING THAT THE PROCUREMENT OF EARLY WARNING DISPATCH SYSTEM (PHASE II) FOR THE DRRM-PREPAREDNESS MITIGATION BE DONE THROUGH THE ALTERNATIVE MODE OF PROCUREMENT, PARTICULARLY THROUGH NEGOTIATED PROCUREMENT (SMALL VALUE PROCUREMENT) PER RULE XVI OF THE REVISED IMPLEMENTING RULES AND REGULATIONS OF REPUBLIC ACT 9184.

WHEREAS, in accordance with Section 10 of the Implementing Rules and Regulations of Republic Act 9184, as a general rule, Procuring Entities shall adopt public bidding as a general mode of **procurement**, however, in order to promote economy and efficiency and during exceptional cases, it may resort to alternative modes of procurement such as Negotiated Procurement as provided in Rule XVI of the said Implementing Rules;

WHEREAS, to promote economy and efficiency and to address the urgent need of the DRRM-Preparedness Mitigation for early warning dispatch system (phase II) for emergency dispatch and database system development, the Bids And Awards Committee recommends that the procurement of the same be done through Small Value Procurement per Section 53.9 of RA 9184, considering that the amount involved which is Php 950,000.00 does not exceed the maximum amount of One Million Pesos (Php 1,000.000.00), which is the threshold for first class cities, as shown in the attached Purchase Request No. 240328;

WHEREAS, on February 13, 2024, Request for Quotation was posted at the Government Electronic Procurement System (G-EPS) at the BAC Bulletin located at the New Ormoc City Hall Building, at the Superdome and the Bus Terminal, Ormoc City and sent to the following Suppliers for the Procurement of Early Warning Dispatch System (Phase II) for the DRRM-Preparedness Mitigation to wit;

- 1. Datche Security and Automation Systems
- 2. Edulearn
- 3. Idea Engine IT Solutions

WHEREAS, in response to the said posting and RFQ's Sent, on February 19, 2024, only IdeaEngine IT Solutions with business address at 744 Brgy. Tambulilid, Ormoc City., Submitted the lone responsive price quotation with the total amount of NINE HUNDRED FORTY-FIVE THOUSAND PESOS ONLY (Php 945,000.00) as shown in attached Abstract of Quotation dated February 19, 2024 as per attached evaluation report of Mr. Melchizedec M. Yap, BAC TWG dated February 26, 2024;
