BAC RESOLUTION NO. 2024-250

A RESOLUTION RECOMMENDING THAT THE PROCUREMENT CCTV EQUIPMENT AND ACCESSORIES FOR THE ORMOC SLAUGHTERHOUSE BE DONE THROUGH THE ALTERNATIVE MODE OF PROCUREMENT, PARTICULARLY THROUGH NEGOTIATED PROCUREMENT (SMALL VALUE PROCUREMENT) PER RULE XVI OF THE REVISED IMPLEMENTING RULES AND REGULATIONS OF REPUBLIC ACT 9184.

WHEREAS, in accordance with Section 10 of the Implementing Rules and Regulations of Republic Act 9184, as a general rule, Procuring Entities shall adopt public bidding as a general mode of **procurement**, however, in order to promote economy and efficiency and during exceptional cases, it may resort to alternative modes of procurement such as Negotiated Procurement as provided in Rule XVI of the said Implementing Rules;

WHEREAS, to promote economy and efficiency and to address the urgent need of **Ormoc Slaughterhouse** for CCTV equipment and accessories, the **Bids And Awards Committee** recommends that the procurement of the same be done through **Small Value Procurement per Section 53.9 of RA 9184**, considering that the amount involved which is **Php 150,000.00** does not exceed the **maximum amount of One Million Pesos (Php 1,000,000.00)**, which is the threshold for first class cities, as shown in the attached **Purchase Request No.240605**;

WHEREAS, on **February 13, 2024**, Request for Quotation was posted at the Government Electronic Procurement System (G-EPS) at the BAC Bulletin located at the New Ormoc City Hall Building, at the Superdome and the Bus Terminal, Ormoc City and sent to the following Suppliers for the Procurement of CCTV equipment and accessories for the Ormoc Slaughterhouse to wit;

1. M and A CCTV Trading
2. Alvi Marketing
3. Ormoc PC Specialist

WHEREAS, in response to the RFQ's Sent, on February 19, 2024 the following Suppliers submitted their respective quotations to wit:

1. M and A CCTV Trading – Php 145,000.00
2. Ormoc PC Specialist – Php 144,100.00

WHEREAS, Ormoc PC Specialist., with business address at Ground Floor, Block 103 Superdome Bldg. Dist. 12 Ormoc City, submitted the lowest responsive price quotation among prospective suppliers with the total amount of ONE HUNDRED FORTY-FOUR THOUSAND ONE HUNDRED PESOS ONLY (Php 144,100.00) as shown in attached Abstract of Quotation dated February 19, 2024 and per attached Evaluation Report of Melchizedec M. Yap, BAC TWG dated February 26, 2024;

On mass motion, considering the foregoing premises, be it resolved as it hereby resolves,
