BAC RESOLUTION NO. 2024-267

A RESOLUTION RECOMMENDING THAT THE PROCUREMENT OF LAPTOP FOR THE ORMOC CITY HOUSING OFFICE BE DONE THROUGH THE ALTERNATIVE MODE OF PROCUREMENT, PARTICULARLY THROUGH NEGOTIATED PROCUREMENT (SMALL VALUE PROCUREMENT) PER RULE XVI OF THE REVISED IMPLEMENTING RULES AND REGULATIONS OF REPUBLIC ACT 9184.

WHEREAS, in accordance with Section 10 of the Implementing Rules and Regulations of Republic Act 9184, as a general rule, Procuring Entities shall adopt public bidding as a general mode of **procurement**, however, in order to promote economy and efficiency and during exceptional cases, it may resort to alternative modes of procurement such as Negotiated Procurement as provided in Rule XVI of the said Implementing Rules;

WHEREAS, to promote economy and efficiency and to address the urgent need of **Ormoc City Housing Office** for laptop, the **Bids and Awards Committee** recommends that the procurement of the same be done through **Small Value Procurement per Section 53.9 of RA 9184**, considering that the amount involved which is **Php 60,000.00** does not exceed the **maximum amount of One Million Pesos (Php 1,000,000.00)**, which is the threshold for first class cities, **as shown in the attached Purchase Request No.240635;**

WHEREAS, on **February 13, 2024**, Requests for Quotation were sent to the following Suppliers to wit:

1. Alvi Marketing
2. Shift Tech Trading Inc.
3. Pito Enterprises

WHEREAS, in response to the said posting and RFQ's Sent, on **February 19, 2024**, the following Suppliers submitted their respective quotations to wit:

1. **Shift Tech Trading Inc. – Php 40,000.00**
2. **Photopro Trading & General Merchandise Co. – Php 52,000.00**

WHEREAS, **Shift Tech Trading Inc.**, with business address at **1280 Bonifacio St(s), Brgy. West, Ormoc City**, Submitted the lowest responsive price quotation with the total amount of **FORTY THOUSAND PESOS ONLY (Php 40,000.00)** as shown in attached Abstract of Quotation dated **February 19, 2024** and per attached Evaluation Report of Melchizedec M. Yap, BAC TWG dated **March 12, 2024**;
