BAC RESOLUTION NO. 2024-238

A RESOLUTION RECOMMENDING THAT THE PROCUREMENT OF DRUGS AND MEDICINES FOR THE CITY HEALTH OFFICE BE DONE THROUGH THE ALTERNATIVE MODE OF PROCUREMENT, PARTICULARLY THROUGH NEGOTIATED PROCUREMENT (SMALL VALUE PROCUREMENT) PER RULE XVI OF THE REVISED IMPLEMENTING RULES AND REGULATIONS OF REPUBLIC ACT 9184.

WHEREAS, in accordance with Section 10 of the Implementing Rules and Regulations of Republic Act 9184, as a general rule, Procuring Entities shall adopt public bidding as a general mode of **procurement**, however, in order to promote economy and efficiency and during exceptional cases, it may resort to alternative modes of procurement such as Negotiated Procurement as provided in Rule XVI of the said Implementing Rules;

WHEREAS, to promote economy and efficiency and to address the urgent need of the **City Health Office** for drugs and medicines, the **Bids and Awards Committee** recommends that the procurement of the same be done through **Small Value Procurement per Section 53.9 of RA 9184**, considering that the amount involved which is **Php 770,850.00** does not exceed the **maximum amount of One Million Pesos (Php 1,000,000.00)**, which is the threshold for first class cities, **as shown in the attached Purchase Request No. 240654;**

WHEREAS, on **February 13, 2024**, Request for Quotation was posted at the Government Electronic Procurement System (G-EPS) at the BAC Bulletin located at the New Ormoc City Hall Building, at the Superdome and the Bus Terminal, Ormoc City and sent to the following Suppliers for Procurement of drugs and medicines for the City Health Office to wit;

1. Lifeshield Pharmatrade
2. Alvez Commercial Incorporated
3. Innocare Pharma

WHEREAS, in response to the said posting and RFQ's Sent, on February 19, 2024 the following Suppliers submitted their respective quotations to wit:

1. Lifeshield Pharmatrade – Php 770,000.00
2. Alvez Commercial Incorporated – Php 770,750.00
3. Innocare Pharma – Php 770,750.00

WHEREAS, Lifeshield Pharmatrade, with business address at Lot 13 Block 3 NHA, Baras, Palo, Leyte submitted the lowest responsive price quotation among prospective suppliers with the total amount of SEVEN HUNDRED SEVENTY THOUSAND PESOS ONLY (Php 770,000.00) as shown in attached Abstract of Quotation February 19, 2024;


On mass motion, considering the foregoing premises, be it resolved as it is hereby resolved,
