BAC RESOLUTION NO. 2024- 245

A RESOLUTION RECOMMENDING THAT THE RENTAL OF LIGHTS AND SOUNDS FOR THE CITY MAYOR'S OFFICE DONE THROUGH THE ALTERNATIVE MODE OF PROCUREMENT, PARTICULARLY THROUGH NEGOTIATED PROCUREMENT (SMALL VALUE PROCUREMENT) PER RULE XVI OF THE REVISED IMPLEMENTING RULES AND REGULATIONS OF REPUBLIC ACT 9184.

WHEREAS, in accordance with Section 10 of the Implementing Rules and Regulations of Republic Act 9184, as a general rule, Procuring Entities shall adopt public bidding as a general mode of **procurement**, however, in order to promote economy and efficiency and during exceptional cases, it may resort to alternative modes of procurement such as Negotiated Procurement as provided in Rule XVI of the said Implementing Rules;

WHEREAS, to promote economy and efficiency and to address the urgent need of **City Mayor's Office** to rent lights and sounds, the **Bids and Awards Committee** recommends that the procurement of the same be done through **Small Value Procurement per Section 53.9 of RA 9184**, considering that the amount involved which is **Php 600,000.00** does not exceed the **maximum amount of One Million Pesos (Php 1,000,000.00)**, which is the threshold for first class cities, **as shown in the attached Purchase Request No. 240640;**

WHEREAS, on **February 13, 2024**, Request for Quotation was posted at the Government Electronic Procurement System (G-EPS) at the BAC Bulletin located at the New Ormoc City Hall Building, at the Superdome and the Bus Terminal, Ormoc City and sent to the following suppliers for the Rental of Lights and Sounds for the City Mayor's Office:

1. ✓ Eugsval Light & Sound Services
2. ✓ P Audio Lights and Sounds
3. ✓ V Music Lights and Sounds

WHEREAS, in response to the RFQ's Sent **February 19, 2024** the following Suppliers submitted their respective quotations to wit:

1. Eugsval Light & Sound Services – Php 600,000.00
2. P Audio Lights and Sounds – Php 620,000.00
3. V Music Lights and Sounds – Php 640,000.00

WHEREAS, Eugsval Light and Sound Services with business address at **Purok 3 St(s), Brgy. Naungan Ormoc City**, Submitted the lowest responsive price quotation among prospective suppliers with the total amount of **SIX HUNDRED THOUSAND PESOS ONLY (Php 600,000.00)** as shown in attached Abstract of Quotation dated **February 19, 2024**;

On mass motion, considering the foregoing premises, be it resolved as it is hereby resolved,

THAT THE RENTAL OF LIGHTS AND SOUNDS FOR THE CITY MAYOR'S OFFICE BE DONE THROUGH THE ALTERNATIVE MODE OF PROCUREMENT, PARTICULARLY THROUGH NEGOTIATED PROCUREMENT (SMALL VALUE PROCUREMENT) PER RULE XVI OF THE REVISED IMPLEMENTING RULES AND REGULATIONS OF REPUBLIC ACT 9184 IN FAVOR TO EUGSVAL LIGHT AND SOUND SERVICES.


