## **BAC RESOLUTION NO. 2024-299**

A RESOLUTION RECOMMENDING THAT MAINTENANCE SERVICES OF PUBLIC CEMETERY FOR EXHUMATION OF SKELETAL REMAINS (OLD PUBLIC CEMETERY) FOR THE PUBLIC CITY CEMETERY MANAGEMENT OFFICE BE DONE THROUGH THE ALTERNATIVE MODE OF PROCUREMENT, PARTICULARLY THROUGH NEGOTIATED PROCUREMENT (SMALL VALUE PROCUREMENT) PER RULE XVI OF THE REVISED IMPLEMENTING RULES AND REGULATIONS OF REPUBLIC ACT 9184.

WHEREAS, in accordance with Section 10 of the Implementing Rules and Regulations of Republic Act 9184, as a general rule, Procuring Entities shall adopt public bidding as a general mode of procurement, however, in order to promote economy and efficiency and during exceptional cases, it may resort to alternative modes of procurement such as Negotiated Procurement as provided in Rule XVI of the said Implementing Rules;

WHEREAS, to promote economy and efficiency and to address the urgent need of Public City Cemetery Management Office for maintenance services of public cemetery for exhumation of skeletal remains and relocate the old public cemetery to new public cemetery, the Bids and Awards Committee recommends that the procurement of the same be done through Small Value Procurement per Section 53.9 of RA 9184, considering that the amount involved which is Php 500,000.00 does not exceed the maximum amount of One Million Pesos (Php 1,000.000.00), which is the threshold for first class cities, as shown in the attached Purchase Request No. 240695;

WHEREAS, on February 19, 2024, Request for Quotation was posted at the Government Electronic Procurement System (G-EPS) at the BAC Bulletin located at the New Ormoc City Hall Building, at the Superdome and the Bus Terminal, Ormoc City and sent to the following Suppliers for the Services for the maintenance of public cemetery for exhumation of skeletal remains (old public cemetery) for the Public City Cemetery Management Office to wit:

- 1. Pito Enterprises
- 2. Artsons General Engineering & Construction Services
- 3. Go Enterprises

WHEREAS, in response to the said posting and RFQ's Sent, on February 23, 2024, only Artson General Engineering and Construction, with business address at Blk. 1 Lot 9, La Pradera, Brgy. Tambulilid,Ormoc City Submitted the lone responsive price quotation with the total amount of FOUR HUNDRED NINETY-NINE THOUSAND PESOS ONLY (Php 499,000.00) as shown in attached Abstract of Quotation dated February 23, 2024;

On mass motion, considering the foregoing premises, be it resolved as it is hereby resolved,

THAT THE MAINTENANCE SERVICES OF PUBLIC CEMETERY FOR EXHUMATION OF SKELETAL REMAINS (OLD PUBLIC CEMETERY) FOR THE PUBLIC CITY CEMETERY MANAGEMENT OFFICE BE DONE THROUGH THE ALTERNATIVE MODE OF PROCUREMENT, PARTICULARLY THROUGH NEGOTIATED PROCUREMENT (SMALL VALUE PROCUREMENT) PER RULE XVI OF THE REVISED IMPLEMENTING RULES AND REGULATIONS OF REPUBLIC ACT 9184 IN FAVOR TO ARTSONS GENERAL ENGINEERING AND CONSTRUCTION.
