BAC RESOLUTION NO. 2024-317

A RESOLUTION RECOMMENDING THAT THE PROCUREMENT OF TIRES AND BATTERY EXISTING SERVICE VEHICLE OF THE TRAFFIC ENFORCEMENT AND MANAGEMENT OFFICE BE DONE THROUGH THE ALTERNATIVE MODE OF PROCUREMENT, PARTICULARLY THROUGH NEGOTIATED PROCUREMENT (SMALL VALUE PROCUREMENT) PER RULE XVI OF THE REVISED IMPLEMENTING RULES AND REGULATIONS OF REPUBLIC ACT 9184.

WHEREAS, in accordance with Section 10 of the Implementing Rules and Regulations of Republic Act 9184, as a general rule, Procuring Entities shall adopt public bidding as a general mode of procurement, however, in order to promote economy and efficiency and during exceptional cases, it may resort to alternative modes of procurement such as Negotiated Procurement as provided in Rule XVI of the said Implementing Rules;

WHEREAS, to promote economy and efficiency and to address the urgent need of the Traffic Enforcement and Management Office for tires and battery for their existing service vehicle, the Bids and Awards Committee recommends that the procurement of the same be done through Small Value Procurement per Section 53.9 of RA 9184, considering that the amount involved which is Php 87,000.00 does not exceed the maximum amount of One Million Pesos (Php 1,000.000.00), which is the threshold for first class cities, as shown in the attached Purchase Request No.240500;

WHEREAS, on February 20, 2024, Request for Quotation was posted at the Government Electronic Procurement System (G-EPS) at the BAC Bulletin located at the New Ormoc City Hall Building, at the Superdome and the Bus Terminal, Ormoc City and sent to the following suppliers for the Procurement of tires and battery for the existing service vehicle of the Traffic Enforcement and Management Office:

- 1. TGCentral Corp.
- 2. Catalino Trading
- 3. Uni-real Trading Corporation

WHEREAS, in response to the RFQ's Sent, On February 26, 2024 following Suppliers submitted their respective quotations to wit:

- 1. Catalino Trading Php 55,000.00
- 2. Johann Enterprises Php 84,000.00
- 3. TGCentral Corp. Php 60,500.00

WHEREAS, Catalino Trading with business address at 403 Carlos Tan St., Ormoc City, submitted the lowest responsive price quotation with the total amount of FIFTY-FIVE THOUSAND PESOS ONLY (Php 55,000.00) as shown in attached Abstract of Quotation dated February 26, 2024;

On mass motion, considering the foregoing premises, be it resolved as it hereby resolves,
