BAC RESOLUTION NO. 2024-344

A RESOLUTION RECOMMENDING THAT THE PROCUREMENT OF VARIOUS COMMODITIES FOR THE CITY SOCIAL WELFARE DEPARTMENT BE DONE THROUGH THE ALTERNATIVE MODE OF PROCUREMENT, PARTICULARLY THROUGH NEGOTIATED PROCUREMENT (SMALL VALUE PROCUREMENT) PER RULE XVI OF THE REVISED IMPLEMENTING RULES AND REGULATIONS OF REPUBLIC ACT 9184.

WHEREAS, in accordance with Section 10 of the Implementing Rules and Regulations of Republic Act 9184, as a general rule, Procuring Entities shall adopt public bidding as a general mode of procurement, however, in order to promote economy and efficiency and during exceptional cases, it may resort to alternative modes of procurement such as Negotiated Procurement as provided in Rule XVI of the said Implementing Rules;

WHEREAS, to promote economy and efficiency and to address the urgent need of the City Social Welfare Department for various commodities, the Bids and Awards Committee recommends that the procurement of the same be done through Small Value Procurement per Section 53.9 of RA 9184, considering that the amount involved which is Php 983,000.00 does not exceed the maximum amount of One Million Pesos (Php 1,000.000.00), which is the threshold for first class cities, as shown in the attached Purchase Request No. 240832;

WHEREAS, on February 26, 2024, Request for Quotation was posted at the Government Electronic Procurement System (G-EPS) at the BAC Bulletin located at the New Ormoc City Hall Building, at the Superdome and the Bus Terminal, Ormoc City and sent to the following Suppliers for Procurement of Various commodities for the City Social Welfare Department to wit;

- 2. Sam's Trading
- 3. Bhagat Emporium

WHEREAS, in response to the said posting and RFQ's Sent, on March 01, 2024 the following Suppliers submitted their respective quotations to wit:

- 2. Sam's Trading Php 982,700.00
- 3. Bhagat Emporium Php 982,400.00

WHEREAS, Paramount Trading with business address at Lot 13 block 3 NHA, Baras, Palo, Leyte., submitted the lowest responsive price quotation among prospective suppliers with the total amount of NINE HUNDRED EIGHTY-TWO THOUSAND PESOS ONLY (Php 982,000.00) as shown in attached Abstract of Quotation March 01, 2024;
