BAC RESOLUTION NO. 2024-401

A RESOLUTION RECOMMENDING THAT THE PROCUREMENT OF LAPTOP AND SCANNER FOR THE CITY LEGAL OFFICE BE DONE THROUGH THE ALTERNATIVE MODE OF PROCUREMENT, PARTICULARLY THROUGH NEGOTIATED PROCUREMENT (SMALL VALUE PROCUREMENT) PER RULE XVI OF THE REVISED IMPLEMENTING RULES AND REGULATIONS OF REPUBLIC ACT 9184.

WHEREAS, in accordance with Section 10 of the Implementing Rules and Regulations of Republic Act 9184, as a general rule, Procuring Entities shall adopt public bidding as a general mode of procurement, however, in order to promote economy and efficiency and during exceptional cases, it may resort to alternative modes of procurement such as Negotiated Procurement as provided in Rule XVI of the said Implementing Rules;

WHEREAS, to promote economy and efficiency and to address the urgent need of City Legal Office for laptop and scanner, the Bids and Awards Committee recommends that the procurement of the same be done through Small Value Procurement per Section 53.9 of RA 9184, considering that the amount involved which is Php 166,999.00 does not exceed the maximum amount of One Million Pesos (Php involved which is the threshold for first class cities, as shown in the attached Purchase Request 1,000.000.00), which is the threshold for first class cities, as shown in the attached Purchase Request No.240852;

WHEREAS, on March 05, 2024, Request for Quotation was posted at the Government Electronic Procurement System (G-EPS) at the BAC Bulletin located at the New Ormoc City Hall Building, at the Superdome and the Bus Terminal, Ormoc City and sent to the following Suppliers for the Procurement of laptop and scanner for the city Legal Office to wit:

- 2. Shift Tech Trading Inc.
- 3. Pito Enterprises

WHEREAS, in response to the said posting and RFQ's Sent, on March 11, 2024, only Shift Tech Trading Inc., with business address at 1280 Bonifacio St(s), Brgy. West, Ormoc City, Submitted the fone responsive price quotation with the total amount of ONE HUNDRED SIXTY-SIX THOUSAND NINE HUNDRED NINETY-NINE PESOS ONLY (Php 166,999.00) as shown in attached Abstract of Quotation dated March 11, 2024 and per attached Evaluation Report of Melchizedec M. Yap, BAC TWG dated March 26, 2024;
