BAC RESOLUTION NO. 2024-403

A RESOLUTION RECOMMENDING THAT THE PROCUREMENT OF GAS CHLORINATOR FOR THE ORMOC WATER WORKS SYSTEM ADMINISTRATION BE DONE THROUGH THE ALTERNATIVE MODE OF PROCUREMENT, PARTICULARLY THROUGH NEGOTIATED PROCUREMENT (SMALL VALUE PROCUREMENT) PER RULE XVI OF THE REVISED IMPLEMENTING RULES AND REGULATIONS OF REPUBLIC ACT 9184.

WHEREAS, in accordance with Section 10 of the Implementing Rules and Regulations of Republic Act 9184, as a general rule, Procuring Entities shall adopt public bidding as a general mode of **procurement**, however, in order to promote economy and efficiency and during exceptional cases, it may resort to alternative modes of procurement such as Negotiated Procurement as provided in Rule XVI of the said Implementing Rules;

WHEREAS, to promote economy and efficiency and to address the urgent need of the **Ormoc Water Works System Administration** for gas chlorinator, the **Bids and Awards Committee** recommends that the procurement of the same be done through **Small Value Procurement per Section 53.9 of RA 9184**, considering that the amount involved which is **Php 513,000.00** does not exceed the **maximum amount of One Million Pesos (Php 1,000,000.00)**, which is the threshold for first class cities, **as shown in the attached Purchase Request No. 240714;**

WHEREAS, on **March 05, 2024** Request for Quotation was posted at the Government Electronic Procurement System (G-EPS) at the BAC Bulletin located at the New Ormoc City Hall Building, at the Superdome and the Bus Terminal, Ormoc City and sent to the following Suppliers for the Procurement of gas chlorinator for the Ormoc Water Works System Administration to wit:

1. ✓ Pito Enterprises
2. ✓ Go Enterprises
3. ✓ Uni-Real Trading Corporation

WHEREAS, in response to the said posting and RFQ's Sent, **March 11, 2024**, the following Suppliers submitted their respective quotations to wit:

1. **U1MIG Enterprises – Php 358,077.00**
2. **Uni-real Trading Corporation – Php 512,150.00**


WHEREAS, Uni-Real Trading Corporation with business address at **Osmeña St(s), Brgy. South, Ormoc City**, Submitted the lowest responsive price quotation with the total amount of **FIVE HUNDRED TWELVE THOUSAND ONE HUNDRED FIFTY PESOS ONLY (Php 512,150.00)** as shown in attached Abstract of Quotation dated **March 11, 2024** as per attached evaluation report of **Mr. Ritze Roy B. Ramos, BAC TWG dated March 18, 2024**;
