BAC RESOLUTION NO. 2024-472

A RESOLUTION RECOMMENDING THAT THE PROCUREMENT OF MEDALS FOR THE CITY SPORTS OFFICE BE DONE THROUGH THE ALTERNATIVE MODE OF PROCUREMENT, PARTICULARLY THROUGH NEGOTIATED PROCUREMENT (SMALL VALUE PROCUREMENT) PER RULE XVI OF THE REVISED IMPLEMENTING RULES AND REGULATIONS OF REPUBLIC ACT 9184.

WHEREAS, in accordance with Section 10 of the Implementing Rules and Regulations of Republic Act 9184, as a general rule, Procuring Entities shall adopt public bidding as a general mode of **procurement**, however, in order to promote economy and efficiency and during exceptional cases, it may resort to alternative modes of procurement such as Negotiated Procurement as provided in Rule XVI of the said Implementing Rules;

WHEREAS, to promote economy and efficiency and to address the urgent need of **City Sports Office** for medals, the **Bids and Awards Committee** recommends that the procurement of the same be done through **Small Value Procurement per Section 53.9 of RA 9184**, considering that the amount involved which is **Php 263,250.00** does not exceed the **maximum amount of One Million Pesos (Php 1,000,000.00)**, which is the threshold for first class cities, as shown in the attached **Purchase Request No.240900**;

WHEREAS, on **March 14, 2023**, Request for Quotation was posted at the Government Electronic Procurement System (G-EPS) at the BAC Bulletin located at the New Ormoc City Hall Building, at the Superdome and the Bus Terminal, Ormoc City and sent to the following Suppliers for the Procurement of Medals for the City Sports Office to wit:

1. Gift of God Engraving Services
2. HAP Metal Fabricators
3. MLDB Printing Services

WHEREAS, in response to the said posting and RFQ's Sent, on **March 20, 2024** the following Suppliers submitted their respective quotations to wit:

1. Gift of God Engraving Services – Php 257,850.00
2. MLDB Printing Services – Php 337,500.00
3. HAP Metal Fabricators – Php 315,000.00


WHEREAS, **Gift of God Engraving Services**, with business address at **Lot 10319-D, Ylaya St., Talamban, Cebu City**, Submitted the lowest responsive price quotation among prospective suppliers with the total amount of **TWO HUNDRED FIFTY-SEVEN THOUSAND EIGHT HUNDRED FIFTY PESOS ONLY (Php 257,850.00)** as shown in attached Abstract of Quotation dated **March 20, 2024**;

On mass motion, considering the foregoing premises, be it resolved as it is hereby resolved,
