BAC RESOLUTION NO. 2024-444

A RESOLUTION RECOMMENDING THAT THE LABOR AND MATERIALS FOR THE REPAIR OF EXISTING PATROL VEHICLE OF THE ORMOC CITY POLICE OFFICE, CITY MAYOR'S OFFICE BE DONE THROUGH THE ALTERNATIVE MODE OF PROCUREMENT, PARTICULARLY THROUGH NEGOTIATED PROCUREMENT (SMALL VALUE PROCUREMENT) PER RULE XVI OF THE REVISED IMPLEMENTING RULES AND REGULATIONS OF REPUBLIC ACT 9184.

WHEREAS, in accordance with Section 10 of the Implementing Rules and Regulations of Republic Act 9184, as a general rule, Procuring Entities shall adopt public bidding as a general mode of procurement, however, in order to promote economy and efficiency and during exceptional cases, it may resort to alternative modes of procurement such as Negotiated Procurement as provided in Rule XVI of the said Implementing Rules;

WHEREAS, to promote economy and efficiency and to address the urgent need of City Mayor's Office for labor and materials for the existing service vehicles of the Ormoc City Police Office, the Bids and Awards Committee recommends that the procurement of the same be done through Small Value Procurement per Section 53.9 of RA 9184, considering that the amount involved which is 231,550.00 does not exceed the maximum amount of One Million Pesos (Php 1,000.000.00), which is the threshold for first class cities, as shown in the attached Purchase Request No.240950;

WHEREAS, on March 14, 2024, Request for Quotation was posted at the Government Electronic Procurement System (G-EPS) at the BAC Bulletin located at the New Ormoc City Hall Building, at the Superdome and the Bus Terminal, Ormoc City and sent to the following Suppliers for the Labor and Materials for the existing patrol vehicle of the Ormoc City Police Office, City Mayor's Office to wit:

- Abarico Auto Repair Shops
- 2. MJJ Engineering Works and Services
- 3. ESE Auto Parts Enterprises

WHEREAS, in response to the said posting and RFQ's Sent, on March 20, 2024 only ESE Auto Parts Enterprises, with business address at 474 Rizal St., Dist. 23, Ormoc City, Submitted the lone responsive price quotation with the total amount of TWO HUNDRED THIRTY THOUSAND FIVE HUNDRED FIFTY PESOS ONLY (Php 230,550.00) as shown in attached Abstract of Quotation dated March 20, 2024;

On mass motion, considering the foregoing premises, be it resolved as it is hereby resolved,

THAT THE LABOR AND MATERIALS FOR THE REPAIR OF EXISTING PATROL VEHICLE OF THE ORMOC CITY POLICE OFFICE, CITY MAYOR'S OFFICE BE DONE THROUGH THE ALTERNATIVE MODE OF PROCUREMENT, PARTICULARLY THROUGH NEGOTIATED PROCUREMENT (SMALL VALUE PROCUREMENT) PER RULE XVI OF THE REVISED IMPLEMENTING RULES AND REGULATIONS OF REPUBLIC ACT 9184 IN FAVOR TO ESE AUTO PARTS ENTERPRISES.
