## BAC RESOLUTION NO. 2024-442

A RESOLUTION RECOMMENDING THAT THE PROCUREMENT OF OFFICE CHAIRS FOR THE CITY MAYOR'S OFFICE BE DONE THROUGH THE ALTERNATIVE MODE OF PROCUREMENT, PARTICULARLY THROUGH NEGOTIATED PROCUREMENT (SMALL VALUE PROCUREMENT) PER RULE XVI OF THE REVISED IMPLEMENTING RULES AND REGULATIONS OF REPUBLIC ACT 9184.

WHEREAS, in accordance with Section 10 of the Implementing Rules and Regulations of Republic Act 9184, as a general rule, Procuring Entities shall adopt public bidding as a general mode of procurement, however, in order to promote economy and efficiency and during exceptional cases, it may resort to alternative modes of procurement such as Negotiated Procurement as provided in Rule XVI of the said Implementing Rules;

WHEREAS, to promote economy and efficiency and to address the urgent need of the City Mayor's Office for office chairs, the Bids and Awards Committee recommends that the procurement of the same be done through Small Value Procurement per Section 53.9 of RA 9184, considering that the amount involved which is Php 84,000.00 does not exceed the maximum amount of One Million Pesos (Php 1,000.000.00), which is the threshold for first class cities, as shown in the attached Purchase Reguest No. 240901;

WHEREAS, on March 14, 2024, Request for Quotation was posted at the Government Electronic Procurement System (G-EPS) at the BAC Bulletin located at the New Ormoc City Hall Building, at the Superdome and the Bus Terminal, Ormoc City and sent to the following suppliers for the Procurement of office chairs for the City Mayor's Office to wit;

- 1. Alvi Marketing
- 2. Uni-real Trading Corporation
- 3. Pito Enterprises

WHEREAS, in response to the said posting and RFQ's Sent, on March 20, 2024, the following Suppliers submitted their respective quotations to wit:

- 1. Alvi Marketing Php 84,000.00
- 2. Joanna's Laboratory Enterprises Php 48,000.00

WHEREAS, Alvi Marketing, with business address at Brgy. Alegria, Ormoc City, submitted the lowest responsive price quotation with the total amount of EIGHTY-FOUR THOUSAND PESOS ONLY (Php 84,000.00) as shown in attached Abstract of Quotation dated March 20, 2024 as per attached evaluation report of Mr. Hector C. Salazar, BAC TWG;
