BAC RESOLUTION NO. 2024-451

A RESOLUTION RECOMMENDING THAT THE PROVISION OF MATERIALS FOR THE CONSTRUCTION OF PARTITIONS, FRAMING OF DROP BANNERS, SIGNAGES & FLATFORM FOR NATIONAL ARTS MONTH AT CITY PLAZA FOR THE CITY GENERAL SERVICES OFFICE BE DONE THROUGH THE ALTERNATIVE MODE OF PROCUREMENT, PARTICULARLY THROUGH NEGOTIATED PROCUREMENT (SMALL VALUE PROCUREMENT) PER RULE XVI OF THE REVISED IMPLEMENTING RULES AND REGULATIONS OF REPUBLIC ACT 9184.

WHEREAS, in accordance with Section 10 of the Implementing Rules and Regulations of Republic Act 9184, as a general rule, Procuring Entities shall adopt public bidding as a general mode of procurement, however, in order to promote economy and efficiency and during exceptional cases, it may resort to alternative modes of procurement such as Negotiated Procurement as provided in Rule XVI of the said Implementing Rules;

WHEREAS, to promote economy and efficiency and to address the urgent need of the City General Services Office for materials for the partitions, framing of drop banners, signages & flatform for national arts month at city plaza, the Bids and Awards Committee recommends that the procurement of the same be done through Small Value Procurement per Section 53.9 of RA 9184, considering that the amount involved which is Php 242,980.00 does not exceed the maximum amount of One Million Pesos (Php 1,000.000.00), which is the threshold for first class cities, as shown in the attached Purchase Request No. 240947;

WHEREAS, on March 14, 2024 Request for Quotation was posted at the Government Electronic Procurement System (G-EPS) at the BAC Bulletin located at the New Ormoc City Hall Building, at the Superdome and the Bus Terminal, Ormoc City and sent to the following Suppliers for the provision of materials for the construction of partitions, framing of drop banners, signages & flatform for national arts month at city plaza for the city general services office to wit:

- 1. Artsons General Engineering & Construction Services
- 2. Pito Enterprises
- 3. Uni-Real Trading Corporation

WHEREAS, in response to the said posting and RFQ's Sent, March 20, 2024, only Uni-Real Trading Corporation with business address at Osmeña St(s), District 23, Ormoc City, Submitted the lone responsive price quotation with the total amount of TWO HUNDRED FORTY-TWO THOUSAND NINE HUNDRED FIVE PESOS ONLY (Php 242,905.00) as shown in attached Abstract of Quotation dated March 20, 2024;

On mass motion, considering the foregoing premises, be it resolved as it is hereby resolved,

THAT THE PROVISION OF MATERIALS FOR THE CONSTRUCTION OF PARTITIONS, FRAMING OF DROP BANNERS, SIGNAGES & FLATFORM FOR NATIONAL ARTS MONTH AT CITY PLAZA FOR THE CITY GENERAL SERVICES OFFICE BE DONE THROUGH THE ALTERNATIVE MODE OF PROCUREMENT, PARTICULARLY THROUGH NEGOTIATED PROCUREMENT (SMALL VALUE PROCUREMENT) PER RULE XVI OF THE REVISED IMPLEMENTING RULES AND REGULATIONS OF REPUBLIC ACT 9184 IN FAVOR TO UNI-REAL TRADING CORPORATION.
