**BAC RESOLUTION NO. 2024-505**

**A RESOLUTION RECOMMENDING THAT THE PROCUREMENT OF OIL AND LUBRICANTS FOR THE CITY GENERAL SERVICES OFFICE BE DONE THROUGH THE ALTERNATIVE MODE OF PROCUREMENT, PARTICULARLY THROUGH NEGOTIATED PROCUREMENT (SMALL VALUE PROCUREMENT) PER RULE XVI OF THE REVISED IMPLEMENTING RULES AND REGULATIONS OF REPUBLIC ACT 9184.**

**WHEREAS**, in accordance with Section 10 of the Implementing Rules and Regulations of Republic Act 9184, as a general rule, Procuring Entities shall adopt public bidding as a general mode of **procurement**, however, in order to promote economy and efficiency and during exceptional cases, it may resort to alternative modes of procurement such as Negotiated Procurement as provided in Rule XVI of the said Implementing Rules;

**WHEREAS**, to promote economy and efficiency and to address the urgent need of **City General Services Office** for oil and lubricants, the **Bids And Awards Committee** recommends that the procurement of the same be done through **Small Value Procurement per Section 53.9 of RA 9184**, **considering** that the amount involved which is **Php 558,550.00** does not exceed the **maximum amount of One Million Pesos (Php 1,000,000.00)**, which is the threshold for first class cities, **as shown in the attached Purchase Request No. 241079;**

**WHEREAS**, on **March 25, 2024**, Request for Quotation was posted at the Government Electronic Procurement System (G-EPS) at the BAC Bulletin located at the New Ormoc City Hall Building, at the Superdome and the Bus Terminal, Ormoc City and sent to the following suppliers for the Procurement of Oil and Lubricants of the City General Services Office:

1. -ESE Auto Parts Enterprises
2. Uni-Real Trading Corporation
3. TG Central Corp.

**WHEREAS**, in response to the said posting and RFQ's Sent, on **April 02, 2024** only **Johann Enterprises**, with business address at **Lilia Avenue St(s) Brgy. Cogon, Ormoc City**, Submitted the lone responsive price quotation with the total amount **FIVE HUNDRED FIFTY THOUSAND THREE HUNDRED PESOS ONLY (Php 550,300.00)** as shown in attached Abstract of Quotation dated **April 02, 2024**;
