BAC RESOLUTION NO. 2024-530

A RESOLUTION RECOMMENDING THAT PROVISION OF CARPENTRY AND PAINTING MATERIALS FOR REPAIR OF VARIOUS SPORTS VENUE FOR EVRAA 2024 OF THE CITY GENERAL SERVICES OFFICE BE DONE THROUGH THE ALTERNATIVE MODE OF PROCUREMENT, PARTICULARLY THROUGH NEGOTIATED PROCUREMENT (SMALL VALUE PROCUREMENT) PER RULE XVI OF THE REVISED IMPLEMENTING RULES AND REGULATIONS OF REPUBLIC ACT 9184.

WHEREAS, in accordance with Section 10 of the Implementing Rules and Regulations of Republic Act 9184, as a general rule, Procuring Entities shall adopt public bidding as a general mode of **procurement**, however, in order to promote economy and efficiency and during exceptional cases, it may resort to alternative modes of procurement such as Negotiated Procurement as provided in Rule XVI of the said Implementing Rules;

WHEREAS, to promote economy and efficiency and to address the urgent need of **City General Services Office** for provision of carpentry and painting materials for repair of various sports venue for EVRAA 2024, the **Bids and Awards Committee** recommends that the procurement of the same be done through **Small Value Procurement per Section 53.9 of RA 9184**, considering that the amount involved which is **Php 803,717.00** does not exceed the **maximum amount of One Million Pesos (Php 1,000,000.00)**, which is the threshold for first class cities, as shown in the attached **Purchase Request No. 241114**;

WHEREAS, on **April 02, 2024**, Requests for Quotation were sent to the following Suppliers to wit:

3. ✓ Uni-real Trading Corporation


WHEREAS, in response to the said posting and RFQ's Sent, on **April 08, 2024**, only **Artsons General Engineering and Construction Services**, with business address at **Blk. 1 Lot 9, La Pradera, Brgy. Tambulilid, Ormoc City** Submitted the lone responsive price quotation with the total amount of **EIGHT HUNDRED TWO THOUSAND NINE HUNDRED SIXTY-SIX PESOS 96/100 (Php 802,966.96) ONLY** as shown in attached Abstract of Quotation dated **April 08, 2024**;
