**BAC RESOLUTION NO. 2024-566**

**A RESOLUTION RECOMMENDING THAT THE RENTAL OF AIRCON TENT FOR THE ORMOC CITY TOURISM OFFICE BE DONE THROUGH THE ALTERNATIVE MODE OF PROCUREMENT, PARTICULARLY THROUGH NEGOTIATED PROCUREMENT (SMALL VALUE PROCUREMENT) PER RULE XVI OF THE REVISED IMPLEMENTING RULES AND REGULATIONS OF REPUBLIC ACT 9184.**

**WHEREAS**, in accordance with Section 10 of the Implementing Rules and Regulations of Republic Act 9184, as a general rule, Procuring Entities shall adopt public bidding as a general mode of **procurement**, however, in order to promote economy and efficiency and during exceptional cases, it may resort to alternative modes of procurement such as Negotiated Procurement as provided in Rule XVI of the said Implementing Rules;

**WHEREAS**, to promote economy and efficiency and to address the urgent need of the **Ormoc City Tourism Office** of rental of aircon tent, the **Bids and Awards Committee** recommends that the procurement of the same be done through **Small Value Procurement per Section 53.9 of RA 9184**, **considering** that the amount involved which is **Php 80,000.00** does not exceed the **maximum amount of One Million Pesos (Php 1,000,000.00)**, which is the threshold for first class cities, **as shown in the attached Purchase Request No. 241177;**

**WHEREAS**, on **April 02, 2024**, Request for Quotation was posted at the Government Electronic Procurement System (G-EPS) at the BAC Bulletin located at the New Ormoc City Hall Building, at the Superdome and the Bus Terminal, Ormoc City and sent to the following suppliers for the Rental of Aircon tent for the Ormoc City Tourism Office to wit:

1. Steadfast Events and General Services
2. 3G Party Rentals
3. Bongs Tents & Chair Rental

**WHEREAS**, in response to the said posting and RFQ's Sent, on **April 08, 2024** the following Suppliers submitted their respective quotations to wit:

1. Steadfast Events and General Services – Php 76,000.00
2. 3G Party Rentals – Php 78,000.00
3. Bongs Tents & Chair Rental – Php 80,000.00

**WHEREAS**, Steadfast Events and General Services, with business address at **Degamo's Bldg. Valle St., Brgy. Doña Feliza Z. Mejia, Ormoc City** submitted the lowest responsive price quotation among prospective suppliers with the total amount of **SEVENTY-SIX THOUSAND PESOS ONLY (Php 76,000.00)** as shown in attached Abstract of Quotation **April 08, 2024**;
