## BAC RESOLUTION NO. 2024-533

A RESOLUTION RECOMMENDING THAT THE PROCUREMENT OF ELECTRICAL SUPPLIES FOR THE CITY GENERAL SERVICES OFFICE BE DONE THROUGH THE ALTERNATIVE MODE OF PROCUREMENT, PARTICULARLY THROUGH NEGOTIATED PROCUREMENT (SMALL VALUE PROCUREMENT) PER RULE XVI OF THE REVISED IMPLEMENTING RULES AND REGULATIONS OF REPUBLIC ACT 9184.

**WHEREAS**, in accordance with Section 10 of the Implementing Rules and Regulations of Republic Act 9184, as a general rule, Procuring Entities shall adopt public bidding as a general mode of **procurement**, however, in order to promote economy and efficiency and during exceptional cases, it may resort to alternative modes of procurement such as Negotiated Procurement as provided in Rule XVI of the said Implementing Rules;

WHEREAS, to promote economy and efficiency and to address the urgent need of the City General Services Office for electrical supplies, the Bids and Awards Committee recommends that the procurement of the same be done through Small Value Procurement per Section 53.9 of RA 9184, considering that the amount involved which is Php 585,336.00 does not exceed the maximum amount of One Million Pesos (Php 1,000.000.00), which is the threshold for first class cities, as shown in the attached Purchase Request No. 241116;

WHEREAS, on April 02, 2024, Request for Quotation was posted at the Government Electronic Procurement System (G-EPS) at the BAC Bulletin located at the New Ormoc City Hall Building, at the Superdome and the Bus Terminal, Ormoc City and sent to the following Suppliers for the Procurement of electrical supplies for the City General Services Office to wit;

- 3. Wilkinson Construction

WHEREAS, in response to the said posting and RFQ's Sent, on April 08, 2024, the following Suppliers submitted their respective quotations to wit:

- 5. Ecoelectric Solutions Php 349,893.38
- 6. Uplite General Merchandise Php 206,900.00

WHEREAS, Bacolod republic Hardware Inc., with business address at Bonifacio Street, Bacolod City Negros Occidental, Negros Island Region, submitted the lowest responsive price quotation with the total amount of THREE HUNDRED FORTY-EIGHT THOUSAND FIVE HUNDRED FIFTY PESOS ONLY (Php 348,550.00) as shown in attached Abstract of Quotation dated April 08, 2024 as per attached evaluation report of Mr. Dexter B. Jumao-as, BAC TWG dated April 22, 2024;
