BAC RESOLUTION NO. 2024-619

A RESOLUTION RECOMMENDING THAT THE RENTAL, VENUE, HOTEL ACCOMMODATION WITH MEALS AND SNACKS FOR THE SANGGUNIANG PANLUNGSOD BE DONE THROUGH THE ALTERNATIVE MODE OF PROCUREMENT, PARTICULARLY THROUGH NEGOTIATED PROCUREMENT (SMALL VALUE PROCUREMENT) PER RULE XVI OF THE REVISED IMPLEMENTING RULES AND REGULATIONS OF REPUBLIC ACT 9184.

WHEREAS, in accordance with Section 10 of the Implementing Rules and Regulations of Republic Act 9184, as a general rule, Procuring Entities shall adopt public bidding as a general mode of **procurement**, however, in order to promote economy and efficiency and during exceptional cases, it may resort to alternative modes of procurement such as Negotiated Procurement as provided in Rule XVI of the said Implementing Rules;

WHEREAS, to promote economy and efficiency and to address the urgent need of the **Sangguniang Panlungsod** to rent, venue, hotel accommodation with meals and snacks at Panglao Island, Bohol, the **Bids and Awards Committee** recommends that the procurement of the same be done through **Small Value Procurement per Section 53.9 of RA 9184**, considering that the amount involved which is **Php 700,000.00** does not exceed the **maximum amount of One Million Pesos (Php 1,000,000.00)**, which is the threshold for first class cities, **as shown in the attached Purchase Request No. 241204;**

WHEREAS, on **April 03, 2024**, Request for Quotation was posted at the Government Electronic Procurement System (G-EPS) at the BAC Bulletin located at the New Ormoc City Hall Building, at the Superdome and the Bus Terminal, Ormoc City and sent to the following Suppliers for Rental, Venue, Hotel Accommodation with Meals/Snacks for the Sangguniang Panlungsod to wit;

1. Belle South Pacific Properties Inc.
2. Modala Beach Resort
3. Panglao Bluewater Beach Resort

WHEREAS, on **April 5, 2024**, per attached certification no. 10716503-01, the RFQ opening scheduled on April 10, 2024 was re-scheduled on April 11, 2024 due to proclamation no 514 declaring April 10, 2024 as a National Holiday throughout the country in observance of Eid al-Fitr (Feast of Ramadan).

WHEREAS, in response to the said posting and RFQ's Sent, the following Suppliers submitted their respective quotations to wit:

1. Belle South Pacific Properties Inc. – php 700,000
2. Modala Beach Resort – php 1,200,000
3. Panglao Bluewater Beach Resort – 997,000

WHEREAS, Belle South Pacific Properties Inc., with business address at P-6, Doljo, Panglao Bohol submitted the **lowest** responsive price quotation among prospective suppliers with the total amount of **SEVEN HUNDRED THOUSAND PESOS ONLY (Php 700,000.00)** as shown in attached Abstract of Quotation **April 11, 2024;**
