BAC RESOLUTION NO. 2024-616

A RESOLUTION RECOMMENDING THAT PROVISION AND INSTALLATION OF FIBER RESIN BALLS FOR THE CITY MAYOR'S OFFICE BE DONE THROUGH THE ALTERNATIVE MODE OF PROCUREMENT, PARTICULARLY THROUGH NEGOTIATED PROCUREMENT (SMALL VALUE PROCUREMENT) PER RULE XVI OF THE REVISED IMPLEMENTING RULES AND REGULATIONS OF REPUBLIC ACT 9184.

WHEREAS, in accordance with Section 10 of the Implementing Rules and Regulations of Republic Act 9184, as a general rule, Procuring Entities shall adopt public bidding as a general mode of **procurement**, however, in order to promote economy and efficiency and during exceptional cases, it may resort to alternative modes of procurement such as Negotiated Procurement as provided in Rule XVI of the said Implementing Rules;

WHEREAS, to promote economy and efficiency and to address the urgent need of **City Mayor's Office** for provision and installation of fiber resin balls at City Plaza and Rotundas, the **Bids and Awards Committee** recommends that the procurement of the same be done through **Small Value Procurement per Section 53.9 of RA 9184**, considering that the amount involved which is **Php 995,000.00** does not exceed the **maximum amount of One Million Pesos (Php 1,000,000.00)**, which is the threshold for first class cities, as shown in the attached **Purchase Request No.241211**;

WHEREAS, on **April 03, 2024**, Request for Quotation was posted at the Government Electronic Procurement System (G-EPS) at the BAC Bulletin located at the New Ormoc City Hall Building, at the Superdome and the Bus Terminal, Ormoc City and sent to the following Suppliers for Provision and Installation of Fiber Resin Balls for the City Mayor's Office. to wit:

1. Stage Mover
2. Dreamset Stage Design and Props
3. Artist Concept

WHEREAS, on **April 05, 2024** the BAC Chairman thru a clarification, re-scheduled all the BAC activities of **April 10, 2024 to April 11, 2024** at the same time and venue due to proclamation no 514 declaring April 10, 2024 as a National Holiday throughout the country in observance of Eid al-Fitr (Feast of Ramadan).


WHEREAS, in response to the said posting and RFQ's Sent, only **Dreamset Stage Design and Props**, with business address at **929 Topaz St. San Bartolome District 5, Quezon City** Submitted the lone responsive price quotation with the total amount of **NINE HUNDRED NINETY- FIVE THOUSAND PESOS (Php 995,000.00) ONLY** as shown in attached Abstract of Quotation dated **April 11, 2024**;


On mass motion, considering the foregoing premises, be it resolved as it is hereby resolved,
