BAC RESOLUTION NO. 2024-602

A RESOLUTION RECOMMENDING THAT THE PROCUREMENT OF TRUMPETS, WATERPROOF PAR LIGHT, ETC. FOR THE CITY MAYOR'S OFFICE BE DONE THROUGH THE ALTERNATIVE MODE OF PROCUREMENT, PARTICULARLY THROUGH NEGOTIATED PROCUREMENT (SMALL VALUE PROCUREMENT) PER RULE XVI OF THE REVISED IMPLEMENTING RULES AND REGULATIONS OF REPUBLIC ACT 9184.

WHEREAS, in accordance with Section 10 of the Implementing Rules and Regulations of Republic Act 9184, as a general rule, Procuring Entities shall adopt public bidding as a general mode of procurement, however, in order to promote economy and efficiency and during exceptional cases, it may resort to alternative modes of procurement such as Negotiated Procurement as provided in Rule XVI of the said Implementing Rules;

WHEREAS, to promote economy and efficiency and to address the urgent need of the City Mayor's Office for Trumpets, waterproof Par Light, and etc., the Bids and Awards Committee recommends that the procurement of the same be done through Small Value Procurement per Section 53.9 of RA 9184, considering that the amount involved which is Php 565,412.00 does not exceed the maximum amount of One Million Pesos (Php 1,000.000.00), which is the threshold for first class cities, as shown in the attached Purchase Request No. 241155;

WHEREAS, on April 05, 2024, Request for Quotation was posted at the Government Electronic Procurement System (G-EPS) at the BAC Bulletin located at the New Ormoc City Hall Building, at the Superdome and the Bus Terminal, Ormoc City and sent to the following Suppliers for the Procurement of Trumpets, waterproof Par Light, and etc. for the City Mayor's Office to wit;

- 1. Electronics City & Service Center, Inc.
- 2. Harmanson
- 3. JVS Audio System

WHEREAS, in response to the said RFQ's Sent, on April 11, 2024, only JVS Audio System, with business address at #2 & 3 PCL Bldg. Diversion Road Brgy. 110-Utap, Tacloban City, submitted the lone responsive price quotation among prospective suppliers with the total amount of FOUR HUNDRED EIGHTY-ONE THOUSAND EIGHT HUNDRED TEN PESOS ONLY (Php 481,810.00) as shown in attached Abstract of Quotation dated April 11, 2024;

On mass motion, considering the foregoing premises, be it resolved as it is hereby resolved,
