BAC RESOLUTION NO. 2024-638

A RESOLUTION RECOMMENDING THAT SUPPLY, DELIVERY AND INSTALLATION OF TEMPORARY STAGE FOR EVRAA 2024 FOR THE ORMOC CITY TOURISM OFFICE BE DONE THROUGH THE ALTERNATIVE MODE OF PROCUREMENT, PARTICULARLY THROUGH NEGOTIATED PROCUREMENT (SMALL VALUE PROCUREMENT) PER RULE XVI OF THE REVISED IMPLEMENTING RULES AND REGULATIONS OF REPUBLIC ACT 9184.

WHEREAS, in accordance with Section 10 of the Implementing Rules and Regulations of Republic Act 9184, as a general rule, Procuring Entities shall adopt public bidding as a general mode of procurement, however, in order to promote economy and efficiency and during exceptional cases, it may resort to alternative modes of procurement such as Negotiated Procurement as provided in Rule XVI of the said Implementing Rules;

WHEREAS, to promote economy and efficiency and to address the urgent need of Ormoc City Tourism Office for installation of temporary stage for EVRAA 2024, the Bids and Awards Committee recommends that the procurement of the same be done through Small Value Procurement per Section 53.9 of RA 9184, considering that the amount involved which is Php 998,920.00 does not exceed the maximum amount of One Million Pesos (Php 1,000.000.00), which is the threshold for first class cities, as shown in the attached Purchase Request No.241213;

WHEREAS, on April 15, 2024, Request for Quotation was posted at the Government Electronic Procurement System (G-EPS) at the BAC Bulletin located at the New Ormoc City Hall Building, at the Superdome and the Bus Terminal, Ormoc City and sent to the following Suppliers for supply, delivery and installation of temporary stage for EVRAA 2024 for the Ormoc City Tourism Office to wit:

- 1. Creative Creature
- 2. Dreamset Stage Design and Props
- 3. Stage Unlimited



WHEREAS, in response to the said posting and RFQ's Sent, on April 19, 2024, only Dreamset Stage Design and Props, with business address at 929 Topaz St. San Bartolome District 5, Quezon City Submitted the lone responsive price quotation with the total amount of NINE HUNDRED NINETY-EIGHT THOUSAND NINE HUNDRED TWENTY PESOS (Php 998,920.00) ONLY as shown in attached Abstract of Quotation dated April 19, 2024;

On mass motion, considering the foregoing premises, be it resolved as it is hereby resolved,
