BAC RESOLUTION NO. 2024-726

A RESOLUTION RECOMMENDING THAT THE PROCUREMENT DIGITAL CAMERA AND CAMERA LENS FOR THE SANGGUNIANG PANLUNGSOD BE DONE THROUGH THE ALTERNATIVE MODE OF PROCUREMENT, PARTICULARLY THROUGH NEGOTIATED PROCUREMENT (SMALL VALUE PROCUREMENT) PER RULE XVI OF THE REVISED IMPLEMENTING RULES AND REGULATIONS OF REPUBLIC ACT 9184.

WHEREAS, in accordance with Section 10 of the Implementing Rules and Regulations of Republic Act 9184, as a general rule, Procuring Entities shall adopt public bidding as a general mode of **procurement**, however, in order to promote economy and efficiency and during exceptional cases, it may resort to alternative modes of procurement such as Negotiated Procurement as provided in Rule XVI of the said Implementing Rules;

WHEREAS, to promote economy and efficiency and to address the urgent need of **Sangguniang Panlungsod** for digital camera and camera lens, the **Bids And Awards Committee** recommends that the procurement of the same be done through **Small Value Procurement per Section 53.9 of RA 9184**, considering that the amount involved which is **Php 515,000.00** does not exceed the **maximum amount of One Million Pesos (Php 1,000,000.00)**, which is the threshold for first class cities, as shown in the attached **Purchase Request No.241366**;

WHEREAS, on **April 23, 2024**, Request for Quotation was posted at the Government Electronic Procurement System (G-EPS) at the BAC Bulletin located at the New Ormoc City Hall Building, at the Superdome and the Bus Terminal, Ormoc City and sent to the following Suppliers for the Procurement of digital camera and camera lens for the Sangguniang Panlungsod to wit;

1. Shift Tech Trading Inc.
2. Pito Enterprises
3. Ormoc PC Specialist

WHEREAS, in response to the RFQ's Sent, on April 29, 2024 only Ormoc PC Specialist., with business address at Ormoc Superdome Bldg. Mahogany St(s). Brgy. South, Ormoc City, submitted the lone responsive price quotation among prospective suppliers with the total amount of FIVE HUNDRED FOURTEEN THOUSAND FIVE HUNDRED EIGHTY-FOUR PESOS ONLY (Php 514,584.00) as shown in attached Abstract of Quotation dated April 29, 2024 as per attached evaluation report of Mr. Melchizedec M. Yap, BAC TWG dated May 06, 2024;
