BAC RESOLUTION NO. 2023- 1800

A RESOLUTION RECOMMENDING THAT THE INSTALLATION OF 3 PHASE POWER SUPPLY TO DAYHAGAN PUMPING STATION FOR THE ORMOC WATERWORKS SYSTEM ADMINISTRATION BE DONE THROUGH THE ALTERNATIVE MODE OF PROCUREMENT, PARTICULARLY THROUGH DIRECT CONTRACTING PER SECTION 50 (C), RULE XVI OF THE REVISED IMPLEMENTING RULES AND REGULATIONS OF REPUBLIC ACT 9184;

WHEREAS, in accordance with Section 10 of the Implementing Rules and Regulations of Republic Act 9184, as a general rule, Procuring Entities shall adopt public bidding as a general mode of **procurement**, however, in order to promote economy and efficiency and during exceptional cases, it may resort to alternative modes of procurement such as Direct Contracting as provided in Section 50, Rule XVI of the said Implementing Rules;

WHEREAS, to promote economy and efficiency and to address the urgent need of the **Ormoc Waterworks System Administration** to install 3 phase power supply to Dayhagan pumping stations, the **Bids And Awards Committee** recommends that the procurement of the same be done through Direct Contracting as per **Section 50 (C), Rule XVI of Republic Act 9184** to wit following Appendix 21, re; Guidelines on Procurement of Water, Electricity, Telecommunications and Internet Service Providers of the same IRR as shown in the attached **Purchase Request No. 232823;**



WHEREAS, LEYTE V ELECTRIC COOPERATIVE, INC. with business address at Brgy. San Pablo, Ormoc City, Leyte is the only electricity service providers who exclusively operates within Ormoc City and Neighboring Town thus, the said electricity services is awarded to them with a total amount of FIVE HUNDRED FORTY-FIVE THOUSAND HUNDRED EIGHTY-FIVE PESOS & 52/100 ONLY (Php 545 ,085.52) only:
