## BAC RESOLUTION NO. 2024- 019

A RESOLUTION RECOMMENDING THAT THE INTERNET SUBSCRIPTION SERVICES FOR THE CITY HEALTH OFFICE BE DONE THROUGH THE ALTERNATIVE MODE OF PROCUREMENT, PARTICULARLY THROUGH DIRECT CONTRACTING PER SECTION 50 (C), RULE XVI OF THE REVISED IMPLEMENTING RULES AND REGULATIONS OF REPUBLIC ACT 9184;

WHEREAS, in accordance with Section 10 of the Implementing Rules and Regulations of Republic Act 9184, as a general rule, Procuring Entities shall adopt public bidding as a general mode of procurement, however, in order to promote economy and efficiency and during exceptional cases, it may resort to alternative modes of procurement such as Direct Contracting as provided in Section 50, Rule XVI of the said Implementing Rules;

WHEREAS, to promote economy and efficiency and to address the urgent need of the City Health Office for internet subscription services for the existing converge speed of 80mbps, the Bids and Awards Committee recommends that the procurement of the same be done through Direct Contracting as per Section 50 (C), Rule XVI of Republic Act 9184 to wit following Appendix 21, re; Guidelines on Procurement of Water, Electricity, Telecommunications and Internet Service Providers of the same IRR as shown in the attached Purchase Request No. 233002;



WHEREAS, the existing internet subscription services of the City Health Office is provided by Converge Info & Communications Tech Solutions Inc. with business address at Super A.S Liok Blgd. Lilia Ave., Purol Jasmin, Brgy. Cogon, Ormoc City Their Continuity ensures proper coordination within the organization and the efficient delivery of public service. Thus, the said internet services is awarded to them with a total amount of TWO HUNDRED FORTY THOUSAND PESOS ONLY (Php 240,000.00) only:
