**BAC RESOLUTION NO. 2024-219**

**A RESOLUTION RECOMMENDING THAT THE SEPTAGE TREATMENT FACILITY REHABILITATION FOR THE CITY GENERAL SERVICES OFFICE BE DONE THROUGH THE ALTERNATIVE MODE OF PROCUREMENT, PARTICULARLY THROUGH DIRECT CONTRACTING PER SECTION 50 (B), RULE XVI OF THE REVISED IMPLEMENTING RULES AND REGULATIONS OF REPUBLIC ACT 9184;**

**WHEREAS**, in accordance with Section 10 of the Implementing Rules and Regulations of Republic Act 9184, as a general rule, Procuring Entities shall adopt public bidding as a general mode of **procurement**, however, in order to promote economy and efficiency and during exceptional cases, it may resort to alternative modes of procurement such as Direct Contracting as provided in Section 50, Rule XVI of the said Implementing Rules;

**WHEREAS**, to promote economy and efficiency and to address the urgent need of the **City General Services Office** to rehabilitate the septage treatment facility, focusing on equipment parts and replacement and mechanical works, the **Bids and Awards Committee** recommends that the procurement of the same be done through **Direct Contracting per Section 50 (B), Rule XVI of the Republic Act 9184 to wit as shown in the attached Purchase Request No.240559;**

WHEREAS, the machinery and equipment for septage treatment facility of the City General Services Office was purchased at the Chemical Research Products Industrial Sales, Inc. with business address at 475, J. P. Rizal St., Mahabang Parang, Santa Maria, Bulacan thus, the rehabilitation, replacement of equipment parts and mechanical works of the same is awarded to them with a total amount of **THREE HUNDRED FIFTEEN THOUSAND PESOS (Php 315,000.00) only:**

On mass motion, considering the foregoing premises, be it resolved as it is hereby resolved,


