BAC RESOLUTION NO. 2024- 363

A RESOLUTION RECOMMENDING THAT THE PROCUREMENT OF DUPLO INKS AND DUPLO MASTER ROLL FOR THE EXISTING DUPLO DIGITAL DUPLICATOR OF THE CITY HEALTH OFFICE BE DONE THROUGH THE ALTERNATIVE MODE OF PROCUREMENT, PARTICULARLY THROUGH DIRECT CONTRACTING PER SECTION 50 (B), RULE XVI OF THE REVISED IMPLEMENTING RULES AND REGULATIONS OF THE REPUBLIC ACT 9184;

WHEREAS, in accordance with Section 10 of the Implementing Rules and Regulations of Republic Act 9184, as a general rule, Procuring Entities shall adopt public bidding as a general mode of **procurement**, however, in order to promote economy and efficiency and during exceptional cases, it may resort to alternative modes of procurement such as Direct Contracting as provided in Section 50, Rule XVI of the said Implementing Rules:

WHEREAS, to promote economy and efficiency and to address the urgent need of the **City Health Office** for Duplo Inks and master roll for their existing Duplo Digital Duplicator, the **Bids and Awards Committee** recommends that the procurement of the same be done through **Direct Contracting** as per **Section 50 (B), Rule XVI of the Republic Act 9184** as shown in the attached **Purchase Request No. 240809;**

WHEREAS, the existing Duplo Digital Duplicator of the City Health Office was purchased at Gakken (Philippines) Inc., with business address G/F Philippines Liong Tek Go Family Asso. Inc., Landco Bus. Legazpi City;

WHEREAS, Gakken (Philippines) Inc. is the exclusive distributor of all Duplo products in the Philippines, as per attached Certificate of Exclusive Distributorship, Thus, the aforementioned items are awarded to them as per attached price quotation, with the total amount of **FIFTY-FIVE THOUSAND NINE HUNDRED FORTY-FIVE PESOS ONLY (Php 55,945.00)** only;


On mass motion, considering the foregoing premises, be it resolved as it is hereby resolved,
