BAC RESOLUTION NO. 2024- 223

A RESOLUTION RECOMMENDING THAT THE PROCUREMENT OF ANNUAL ONLINE SUBSCRIPTION FOR THE CITY LEGAL OFFICE BE DONE THROUGH THE ALTERNATIVE MODE OF PROCUREMENT, PARTICULARLY THROUGH DIRECT CONTRACTING PER SECTION 50 (A), RULE XVI OF THE REVISED IMPLEMENTING RULES AND REGULATIONS OF REPUBLIC ACT 9184;

WHEREAS, in accordance with Section 10 of the Implementing Rules and Regulations of Republic Act 9184, as a general rule, Procuring Entities shall adopt public bidding as a general mode of **procurement**, however, in order to promote economy and efficiency and during exceptional cases, it may resort to alternative modes of procurement such as Direct Contracting as provided in Section 50, Rule XVI of the said Implementing Rules;

WHEREAS, to promote economy and efficiency and to address the urgent need of the **City Legal Office** of Annual Online Subscription for Laws, Taxation, Jurisprudence, ENR, Local Government, Civil Service, Election 6 to 10 IDS, subscription for 12 Months, the **Bids and Awards Committee** recommends that the procurement of the same be done through Direct Contracting as per **Section 50 (A), Rule XVI of Republic Act 9184 as shown in the attached Purchase Request No. 240448;**

WHEREAS, CD TECHNOLOGIES ASIA INC. with business address at Suite 312 Medalle Bldg. Osmeña Bldv. Capitol Site Cebu City 6000, is an online publisher of libraries with Certificates of Copyright Registration and Deposit issued of the Notarial Commission for Culture and the Arts, National Library of the Philippines. Thus, the Procurement of Annual Online Subscription is awarded to them with a total amount of ONE HUNDRED SEVENTY-FOUR THOUSAND SEVEN HUNDRED TWENTY PESOS ONLY (Php 174,720.00) only:


On mass motion, considering the foregoing premises, be it resolved as it is hereby resolved,


